WHEREAS, Ordinance No. 03 dated February 3, 2025 of the Municipality of Carrascal, this Province entitled "An Ordinance Amending Section 4 of Ordinance No. 31, Series of 2023 of the Municipality of Carrascal entitled 'An Ordinance Creating the Position of Labor and Employment Officer I with Salary Grade 11 Under the Office of the Municipal Mayor, Municipality of Carrascal, Surigao del Sur and Providing Funds Thereof', Specifically Rectifying the Educational Qualification Requirement Thereof", was submitted to this Body for review and was referred to the Committee on Good Government, Public Ethics and Accountability and same was endorsed to the Provincial Human Resource Management Officer for his comment and recommendation;
