WHEREAS, in line thereof, a formal request from Jenefer F. Intino, representative of Intino-Autida Real Estate Developers Corps., was submitted to this Sanggunian, seeking for the reclassification of the above-mentioned lands at Purok-5, Brgy. Causwagan, this municipality;

WHEREAS, attached to the letter-request are the following documents:

- 1) **Copies of the Original Certificates of Title;**
- 2) **Copies of Deeds of Sale;**
- 3) **Tax Declarations of the subject lands;**
- 4) **Site Development Plan**
- 5) **Consolidation Scheme with Satellite Image;**
- 6) **Certification from the Municipal Planning and Development Office (MPDO)** affirming that the designated lands are currently utilized as a Commercial Area and are not programmed for any future government projects;
- 7) **Certification from the Provincial Health Office** confirming suitability for cemetery development and future expansion of existing facilities;
- 8) **Certification from the National Water Resources Board** that the water table depth in the concerned area conforms with the minimum allowable 4.50 meters below ground surface (mbgs);
- 9) **Certification from the DENR LUC Form 6** that the subject lands are classified as NOT within protected areas, environmentally critical area (ECA), mossy and virgin forests, riverbanks, swamp forests and marchlands, and that the proposed project is NOT an environmentally critical project (ECP);
- 10) **Copy of Resolution No. 24, series of 2023 of Brgy. Causwagan, Barobo, Surigao del Sur** – *Granting the Approval on the Establishment of Rose Garden Memorial Park to be situated in Brgy. Causwagan, this municipality, subject to compliance with the HLURB Rules and Regulations governing the creation of memorial Parks/Cemeteries pursuant to Executive Order No. 648; and*
- 11) **Copy of Resolution No. 235, series of 2023 of the Sangguniang Bayan of Barobo, Surigao del Sur** – *Interposing no objection to the establishment of Rose Garden Memorial Park, a private cemetery, at Brgy. Causwagan, this municipality;*

WHEREAS, Section 20 of the Local Government Code provides that:

- **Reclassification of Lands.** (a) *A xxx municipality may, through an ordinance passed by the Sangguniang Bayan after conducting a public hearing for the purpose, authorize the reclassification of agricultural lands xxx where the land shall have substantial greater economic value for residential, commercial, or industrial purposes;*

WHEREAS, the Sangguniang Bayan, in compliance to the provision of law, along with the technical persons from the concerned offices and agencies, had conducted a public hearing on March 27, 2025 at the Barangay Gymnasium of Brgy. Causwagan, wherein the barangay officials and the constituents are enthusiastic of the development as this gives economic impact to the barangay, and the municipality as well, thus, there was positive result;

WHEREAS, the Sangguniang Bayan, upon through evaluation of the documents and the intention of reclassification, sees positive impact and substantial benefits, and increased economic opportunities for the barangay and municipality.

NOW THEREFORE:

BE IT ORDAINED, by the Sangguniang Bayan of Barobo, Surigao del Sur, duly assembled in session, **THAT**:

COMMENTS, OBSERVATIONS AND SUGGESTIONS:

Hon. Bernal, the Vice Mayor, stated that the purpose of the public hearing aligns with the output presented during the deliberation by Hon. Mosquera, the Chairman of Environmental Protection, regarding the proposed ordinance on the reclassification of property for the proper utilization of land.

He emphasized that the resource persons are present to address any concerns or clarifications related to the ordinance. Furthermore, he noted that public consultation is essential for the harmonious implementation of the ordinance. He also invited the resource speakers to share their insights.

Hon. Mangga, the Barangay Captain, confirmed that there were no issues regarding the land boundaries, as all concerns had already been resolved.

Engr. Siega, the Municipal Environment and Natural Resources Officer (MENRO), stated that the DENR had already issued a certificate indicating that the area is not located within a critical habitat or protected area. As such, their office is not imposing strict measures, given that the DENR has already certified the area.

He further explained that they have no concerns regarding the reclassification. However, if any development occurs, their office will issue an Environmental Compliance Certificate (ECC), for which a public hearing is one of the requirements.

Ms. Dosdos, the Municipal Health Officer (MHO), confirmed that their office, along with the Regional Sanitary Engineer and staff, conducted an inspection of the area on March 15, 2025, and subsequently issued a certification. She further stated that, since all necessary documents have been complied with, the regional office has recommended proceeding with Phase 1. The only concern raised was that the engineer requested the submission of the original documents for verification and photocopying, after which they will be returned to the owner. Therefore, the Municipal Health Office has no other concerns regarding the matter.

Ms. Bucoy, representing the Office of the Municipal Agriculturist (OMag), stated that changes and progress in land conversion from agricultural to commercial use are inevitable. The office has no objections as long as the land is properly utilized. However, she reminded the developer that if there is a need to cut any coconut trees, they must secure a cutting permit from the office beforehand.

Ms. Cabusas, the Municipal Assessor, reminded the attendees that the tax declaration will be updated to reflect the reclassification. Consequently, the barangay's tax share will also increase since the land has been converted to commercial use.

She further stated that there are no issues on their part regarding the land assessment, as they will adhere to the provisions of the ordinance.

Mr. Obenza, MPDO-Draftman, stated that the office has already issued the certification, indicating its approval. He added that once the land is officially reclassified, it will be reflected in the land use plan.

Mr. Nacario, the Business Permit and Licensing Officer (BPLO), stated that the BPLO will become involved once the business is operational. He noted that this venture would be beneficial both to the municipality and to the residents of Causwagan, as they will also gain from the business.

He further remarked that having a memorial park like this, similar to San Lorenzo, would provide a place where people can gather to honor and remember their departed loved ones.

Hon. Bernal, the Vice Mayor, stated that the Sanggunian Bayan welcomes and supports all investors, provided that they comply with the rules, regulations, and policies of the Municipality of Barobo.

Hon. Balahay agreed with the statement of the Vice Mayor regarding the support extended by the Sanggunian Bayan to investors. He also expressed his gratitude to the developer for their trust and for choosing Barobo as the location for their business investment.

Furthermore, he encouraged the residents to voice any concerns or clarifications so that these can be addressed immediately before the ordinance is approved.

Hon. Bacolod, the Chairman of Ways and Means, stated that this ordinance will contribute to increasing the municipality's income and attract more investors. She also expressed her gratitude to the developer for choosing Barobo, noting that this investment will help boost the local economy and improve Barangay Causwagan. She highlighted that, as of now, Barangay Causwagan is one of the top barangays attracting investors.

Hon. Bernal stated that this will have a domino effect, as more investors will be encouraged to come and invest in the Municipality of Barobo, resulting in increased economic activity.

Hon. Mosquera also affirmed that this year is indeed a year of prosperity for Barangay Causwagan.

Ms. Intino, the developer, expressed her gratitude for the full support provided by the legislative and barangay officials. She also assured that all the workers are residents of Barangay Causwagan.
