AFFIRMING ORDINANCE NO. 56 DATED MARCH 04, 2025 OF THE MUNICIPALITY OF SAN AGUSTIN, THIS PROVINCE ENTITLED "ORDINANCE INSTITUTIONALIZING THE KATUWANG SA DIWA AT GAWA PARA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO IN THE MUNICIPALITY OF SAN AGUSTIN, PROVINCE OF SURIGAO DEL SUR", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by the Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 56 dated March 04, 2025 of the Municipality of San Agustin, this Province entitled "Ordinance Institutionalizing the Katuwang sa Diwa at Gawa Para sa Masaganang Ani at Mataas na Kita (KADIWA) ng Pangulo in the Municipality of San Agustin, Province of Surigao del Sur", was submitted to this Body for review and same was referred to the Committee on ~~Cooperatives and Livelihood~~ ^{Agriculture Fisheries} (Lead Committee) ~~Good Government, Public Ethics and Accountability~~ appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
