AFFIRMING ORDINANCE NO. 009 DATED MARCH 26, 2025 OF THE CITY OF TANDAG, THIS PROVINCE ENTITLED “FURTHER AMENDING SECTION 4.A., SECTION 5.A., SECTION 6.B., AND SECTION 7.A.2. OF ORDINANCE NO. 004-2025 ENTITLED AN ORDINANCE AMENDING ORDINANCE NO. 033-2024, OTHERWISE KNOWN AS ‘AN ORDINANCE ESTABLISHING THE NONAGENARIAN AWARD TO QUALIFIED RESIDENTS OF THE CITY, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES’”, IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN PANLUNGSOD CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the Sangguniang Panlalawigan shall review all ordinances approved by the Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor”;

WHEREAS, Ordinance No. 009 dated March 26, 2025 of the City of Tandag, this Province entitled “Further Amending Section 4.a., Section 5.a., Section 6.b., and Section 7.a.2. of Ordinance No. 004-2025 entitled An Ordinance Amending Ordinance No. 033-2024, Otherwise Known as ‘An Ordinance Establishing the Nonagenarian Award to Qualified Residents of the City, Providing Funds Therefor and for Other Purposes’”, was submitted to this Body for review and same was referred to the Committee on Differently Abled of Persons with Disabilities and Senior Citizens, and Social Services and Community Development, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 009 dated March 26, 2025 of the City of Tandag, this Province entitled “Further Amending Section 4.a., Section 5.a., Section 6.b., and Section 7.a.2. of Ordinance No. 004-2025 entitled an Ordinance Amending Ordinance No. 033-2024, Otherwise Known as ‘An Ordinance Establishing the Nonagenarian Award to Qualified Residents of the City, Providing Funds Therefor and for Other Purposes’”, it being within the scope of the prescribed powers of the Sangguniang Panlungsod concerned to enact such ordinance pursuant to the Local Government Code of 1991.
