AFFIRMING ORDINANCE NO. 10-25 DATED APRIL 2, 2025 OF THE MUNICIPALITY OF CAGWAIT, THIS PROVINCE ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE MENTAL HEALTH CARE PROGRAM IN THE MUNICIPALITY OF CAGWAIT PROVINCE OF SURIGAO DEL SUR, ESTABLISHING MECHANISMS AND GUIDELINES FOR ITS IMPLEMENTATION, ADOPTING CERTAIN PROVISIONS OF REPUBLIC ACT NO. 11036, APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by the Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 10-25 dated April 2, 2025 of the Municipality of Cagwait, this Province entitled "An Ordinance Institutionalizing the Mental Health Care Program in the Municipality of Cagwait Province of Surigao del Sur, Establishing Mechanisms and Guidelines for its Implementation, Adopting Certain Provisions of Republic Act No. 11036, Appropriating Funds Thereof and for Other Purposes", was submitted to this Body for review and same was referred to the Committee on Health, Sanitation and Nutrition, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 10-25 dated April 2, 2025 of the Municipality of Cagwait, this Province entitled "An Ordinance Institutionalizing the Mental Health Care Program in the Municipality of Cagwait Province of Surigao del Sur, Establishing Mechanisms and Guidelines for its Implementation, Adopting Certain Provisions of Republic Act No. 11036, Appropriating Funds Thereof and for Other Purposes", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such ordinance pursuant to the Local Government Code of 1991.
