

AFFIRMING ORDINANCE NO. 04 DATED FEBRUARY 10, 2025 OF THE MUNICIPALITY OF SAN MIGUEL, THIS PROVINCE ENTITLED "AN ORDINANCE GRANTING A MONTHLY CASH SUBSIDY TO LEARNERS WITH DISABILITIES OR SPECIAL NEEDS OFFICIALLY ENROLLED IN THE SPECIAL NEEDS EDUCATION (SNED) PROGRAM, ALSO KNOWN AS THE KALINGA PROGRAM, IN THE MUNICIPALITY OF SAN MIGUEL", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the **sanggunian** and of the mayor";

WHEREAS, Ordinance No. 04 dated February 10, 2025 of the Municipality of San Miguel, this Province entitled "An Ordinance Granting a Monthly Cash Subsidy to Learners with Disabilities or Special Needs Officially Enrolled in the Special Needs Education (SNED) Program, Also known as the KALINGA Program, in the Municipality of San Miguel", was submitted to this Body for review and same was referred to the Committees on Education (Lead Committee)/Differently Abled or Persons with Disabilities and Senior Citizens, and Social Services and Community Development and was subsequently endorsed to the Provincial Social Welfare and Development Officer, for her comment and recommendation;

WHEREAS, Mrs. Hershe L. Nuñez, RSW, Provincial Social Welfare and Development Officer, this Province, in her letter dated May 21, 2025, after thorough review of the said Ordinance, returned the same without any adverse findings and recommended its adoption;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
