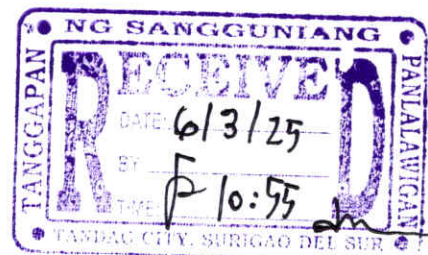

WHEREAS, Hon. Alexander T. Pimentel Provincial Governor, this Province in his letter addressed to the Sangguniang Panlalawigan thru Hon. Manuel O. Alameda, Sr., Vice Governor dated January 24, 2025 requested the August Body for passage of a Resolution authorizing him to enter into and sign a Deed of Donation, for and in behalf of the Provincial Government of Surigao Del Sur, with in the favor of Technical Education and Skills Development Authority- Surigao del Sur Provincial Office, represented by Regional Director Florencio F.
