AFFIRMING ORDINANCE NO. 03 DATED APRIL 23, 2025 OF THE MUNICIPALITY OF MARIHATAG, THIS PROVINCE ENTITLED “AN ORDINANCE GRANTING CASH INCENTIVE/BENEFIT ON A SEMESTRAL BASIS TO MINIMUM AMOUNT OF TWO THOUSAND PESOS (P2,000.00) TO A SOLO PARENT AND APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES”, IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”;

WHEREAS, Ordinance No. 03 dated April 23, 2025 of the Municipality of Marihatag, this Province entitled “An Ordinance Granting Cash Incentive/Benefit on a Semestral Basis to Minimum Amount of Two Thousand Pesos (P2,000.00) to a Solo Parent and Appropriating Funds Thereof and for Other Purposes”, was submitted to this Body for review and same was referred to the Committees on Women, Children and Family Relations (Lead Committee)/ Finance and Appropriation, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 03 dated April 23, 2025 of the Municipality of Marihatag, this Province entitled “An Ordinance Granting Cash Incentive/Benefit on a Semestral Basis to Minimum Amount of Two Thousand Pesos (P2,000.00) to a Solo Parent and Appropriating Funds Thereof and for Other Purposes”, it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
