





ORDINANCE NO. 31-25



AN ORDINANCE INSTITUTIONALIZING THE GRANT OF INCENTIVES TO CAGWAIT MUNICIPAL PUBLIC SCHOOL LEARNERS FOR ACADEMIC ACHIEVEMENT:

WHEREAS, pursuant to Section 2 (3), Article XIV of the Philippine Constitution provides that the state shall established and maintain a system of scholarship grants, students loan programs, subsidies and other incentives which shall be available to deserving students in both Public and Private Schools, especially to the underprivileged;

WHEREAS, in line with the implementation of Republic Act No. 10533, otherwise known as the Enhance Basic Education Act of 2013, the Local Government of Cagwait recognizes the outstanding performance and achievement of garners in academic;

WHEREAS, the Academic Achievers Awards is a recognition for those learners who obtained the top 3 highest general average in Grade 6 and Grade 12 in all public elementary and secondary schools in the Municipality of Cagwait;

WHEREAS, the Cagwait Municipal Government institutionalizes these recognitions to encourage learners to strive for excellence and become proactive members of the school and community especially during extraordinary and challenging times;

NOW THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Cagwait, in session assembled;

SECTION 1. TITLE. This ordinance shall be known as the **"ACADEMIC ACHIEVERS AWARDS ORDINANCE"**.

SECTION 2. DECLARATION OF POLICY. It is the policy of the Municipal Government of Cagwait to recognize exemplary academic achievement of students.

SECTION 3. OBJECTIVES. This ordinance shall have the following objectives;

- a). To recognize exemplary achievements of Grade 6 and Grade 12 graduating learners of the municipality of Cagwait Public Schools;
- b). To encourage learners to strive for excellence.

SECTION 4. INCENTIVES FOR TOP THREE (3) GRADUTING LEARNERS. Graduating learners with the highest general average in the Grade 6 and Grade 12 levels in public elementary and secondary schools shall be granted the following:

4.a) For Grade Six (6) Top Three (3) Academic Achievers:

SECTION 5. APPROPRIATION. The budgetary requirement shall be included in the Annual Appropriations of the General Fund.

SECTION 6. IMPLEMENTING OFFICE. The School District Office (SDO) of Cagwait Municipality shall be the main implementor of this Ordinance.

SECTION 7. IMPLEMENTING RULES AND REGULATIONS. The School District Office (SDO) of Cagwait shall issue the implementing rules and regulations within sixty (60) days from the approval of this ordinance for its effective implementation.

SECTION 8. SEPARABILITY CLAUSE. If any part or section of this Ordinance is declared unconstitutional for any reason whatever such declaration shall not in any way affect other parts or sections of this ordinance.

SECTION 9. REPEALING CLAUSE. All previous ordinance are hereby repealed or modified accordingly if found inconsistent with the provisions of this ordinance.

SECTION 10. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval.


