**AFFIRMING ORDINANCE NO. 2025-11 DATED SEPTEMBER 2, 2025 OF THE CITY OF BISLIG, THIS PROVINCE ENTITLED “AN ORDINANCE ESTABLISHING GUIDELINES FOR THE IMPLEMENTATION OF PRE-EMPTIVE AND FORCED EVACUATION MEASURES IN THE CITY OF BISLIG DURING IMMINENT DISASTERS OR EMERGENCIES”, IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor”;

**WHEREAS**, Ordinance No. 2025-11 dated September 2, 2025 of the City of Bislig, this Province entitled “An Ordinance Establishing Guidelines for the Implementation of Pre-emptive and Forced Evacuation Measures in the City of Bislig During Imminent Disasters or Emergencies”, was submitted to this Body for review and same was referred to the Committee on (Barangay Affairs,) for appropriate action; *Disaster Risk Reduction & Climate Change Adaptation*

**WHEREAS**, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
