**AFFIRMING ORDINANCE NO. 20-25 DATED SEPTEMBER 1, 2025 OF THE MUNICIPALITY OF CAGWAIT, THIS PROVINCE ENTITLED "AN ORDINANCE ESTABLISHING THE GUIDELINES IN THE ADMINISTRATION AND IMPLEMENTATION OF ALL RESETTLEMENT AND SOCIALIZED HOUSING PROGRAM IN THE MUNICIPALITY OF CAGWAIT, PROVINCE OF SURIGAO DEL SUR", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**
