AFFIRMING ORDINANCE NO. 16-25 DATED AUGUST 19, 2025 OF THE MUNICIPALITY OF CAGWAIT, THIS PROVINCE ENTITLED "AN ORDINANCE ESTABLISHING GUIDELINES FOR THE REGULAR TESTING AND MAINTENANCE OF THE MUNICIPALITY'S EMERGENCY SIREN AND ALARM SYSTEM OF CAGWAIT", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 16-25 dated August 19, 2025 of the Municipality of Cagwait, this Province entitled "An Ordinance Establishing Guidelines for the Regular Testing and Maintenance of the Municipality's Emergency Siren and Alarm System of Cagwait", was submitted to this Body for review and same was referred to the Committee on Peace and Order, Public Safety and Anti-Illegal Drugs, for appropriate action;
