**AFFIRMING ORDINANCE NO. 18-25 DATED AUGUST 26, 2025 OF THE MUNICIPALITY OF CAGWAIT, THIS PROVINCE ENTITLED "AN ORDINANCE PROVIDING AWARDS AND INCENTIVES TO THE BARANGAYS OF THE MUNICIPALITY OF CAGWAIT, PROVINCE OF SURIGAO DEL SUR ON THE BASIS FOR HAVING BEEN AWARDED THE SEAL OF GOOD LOCAL GOVERNANCE (SGLGB), APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

**WHEREAS**, Ordinance No. 18-25 dated August 26, 2025 of the Municipality of Cagwait, this Province entitled "An Ordinance Providing Awards and Incentives to the Barangays of the Municipality of Cagwait, Province of Surigao del Sur on the Basis for Having Been Awarded the Seal of Good Local Governance (SGLGB), Appropriating Funds Therefore and for Other Purposes", was submitted to this Body for review and same was referred to the Committee on Barangay Affairs, for appropriate action;

**WHEREAS**, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
