**AFFIRMING ORDINANCE NO. LP-03 DATED SEPTEMBER 30, 2025 OF THE MUNICIPALITY OF TAGO, THIS PROVINCE ENTITLED "AN ORDINANCE REQUIRING THE OWNERS OF VACANT LOTS IN THE MUNICIPALITY OF TAGO, SURIGAO DEL SUR, TO MAINTAIN CLEANLINESS OF THEIR PROPERTIES AND PROVIDING PENALTIES FOR NON-COMPLIANCE", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Chapter 3, Article III, Section 468 Par. (a) No. 1 ( i ) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";
