

**WHEREAS**, the Sangguniang Bayan has the power to authorize and license the establishment, operation, and maintenance of cockpits and regulate cockfighting and commercial breeding of gamecocks: Provided that existing rights should not be prejudiced (Sec. 447, Paragraph 3 (v) of the new Local Government Code of 1991);

**WHEREAS**, in order for the existing ordinance of this Municipality, Ordinance No. 11, series of 2017, to be responsive to the present developments, brought about by the digital era, there is a need to amend some of its provisions;

**NOW, THEREFORE:**

BE IT ORDAINED by the Sangguniang Bayan of Bayabas, Surigao del Sur, in session assembled, that:

**Section 1. TITLE.** The title of this ordinance shall be known as **“AN ORDINANCE AMENDING SECTION 4, PARAGRAPHS 5 AND 9 (b) (7) AND SECTION 5, PARAGRAPH 4 OF MUNICIPAL ORDINANCE NO. 11, SERIES OF 2017.”**

**Section 2. AMENDMENTS:**

A. Section 4: Regulatory Acts.

5. *Should be provided as follows: Regular cockfights, those held during Sundays, legal holidays, and local fiestas shall, be excluded in the payment of fees herein imposed, except Sultadas’ fee for regular cockfights at the rate of ₱ 40.00 to the winning cock as provided under Section 4, (3), (c) of Municipal Ordinance No. 11, series of 2017.*

9. *Requirements for Application of Franchise.*

b. *Renewal*

7. *Should be provided as follows:*

*No Cockpit shall be operated within the radius of 50 meters from schools, other public buildings, residential areas, and churches, and such cockpit shall have sufficient parking areas.*

B. Section 5: Conduct of Cockfighting

4. *Should be provided as follows:*

*Special Cockfight – The Municipal Mayor may issue Special Permits for Special Cockfights provided there is prior approval from the Sangguniang Bayan in a form of a resolution and the cockfight shall be held in the licensed cockpit for not more than three (3) consecutive days, subject to the approval of the local chief of the Philippine National Police (PNP). Special Permit shall only be issued upon the approval of the local chief of the PNP and thereafter, Payment of Special Permit Fee, as provided under Section 4 (3) (b) of Municipal Ordinance No. 11, series of 2017 in the amount of ₱ 600.00, shall have been made.*

**Section 3. SEPARABILITY CLAUSE.** In the event that any part or portion of this ordinance is pronounced or declared invalid or unconstitutional, all other provisions hereof not affected by such pronouncement shall remain in full force and effect.

**Section 4. APPLICABILITY CLAUSE.** All other related matters not specifically provided in this ordinance shall be governed by pertinent existing laws or ordinances.

**Section 5. REPEALING CLAUSE.** All ordinances and other previous local enactments, resolutions, memoranda and other issuances inconsistent with this ordinance are hereby repealed or modified accordingly.

**Section 6. EFFECTIVITY.** This ordinance shall take effect after ten (10) days from the date a copy hereof is posted in the bulletin board at the entrance of the Municipal Building of Bayabas, Surigao del Sur and in at least two (2) conspicuous places in the Municipality.





**AN ORDINANCE PRESCRIBING GUIDELINES FOR THE GRANT OF AN AUTHORITY OR LICENSE TO OPERATE COCKPIT ARENA INCLUDING OTHER REGULATIONS RELATIVE THERETO.**

**WHEREAS**, pursuant to Section 447 (3) (v) of the Local Government Code of 1991, otherwise known as "Republic Act No. 7160," *"Any Law to the Contrary Notwithstanding, authorize and license the establishment, operation and maintenance of cockpits and regulate cockfighting and commercial breeding of gamecocks: Provided, That existing rights should not be prejudiced;*

**WHEREAS**, cockpit arena in this municipality is operating under Resolution No. 52, series of 2003 granting authority to Bayabas Game Cock Association to operate their cockpit arena for a period of 25 years;

**WHEREAS**, the aforementioned Resolution, though duly approved, is considered to be erroneous as the grantee, Bayabas Game Cock Association has no juridical personality;

**WHEREAS**, the location and operation of the existing cockpit arena has been in violation to Paragraph (c), Section 5 of PD 449, otherwise known as the Cockfighting Law of 1974;

**WHEREAS**, this August Body has taken into consideration the application of the new management of the aforesaid cockpit arena, which is to be relocated in an area compliant to Section 5 of PD 449, and this time sole proprietorship, for the issuance of a permit or franchise because since the Bayabas Cockpit Arena started its operation it is continuously paying the required mayor's permit;

**NOW, THEREFORE:**

**BE IT ORDAINED** by the Sangguniang Bayan of Bayabas, Surigao del Sur, in session duly assembled, that;

**SECTION 1: TITLE.** This Ordinance shall be known as the "COCKPIT AND COCKFIGHTING ORDINANCE OF BAYABAS, SURIGAO DEL SUR."

**SECTION 2: DECLARATION OF POLICY.** It is the declared policy of the local government unit of Bayabas to regulate the operation of cockpit and cockfighting in the Municipality of Bayabas consistent with, and in furtherance of public safety, order and security, as well as enhancement of cultural tradition.

**SECTION 3: DEFINITION OF TERMS.** As used in this ordinance the following terms shall mean as;

1. **Cockfighting** – is the sport of fitting or evenly matching gamecocks to engage in an actual fight where bets on either side are laid. Cockfighting may also be formed as "cockfighting derby or pintakasi" or its equivalent in different Philippine localities;
2. **Cockpit Arena** – A commercial building at the center of which is an enclosed cockfighting arena and surrounded by seats provided for bettors and other aficionados;
3. **Fighting Cock/Game Cock** – Also called rooster, whether locally bred or imported or hybrids primarily for cockfighting;
4. **Local Derby** – is an invitational cockfight participated in by game cockers or cockfighting aficionados of the Philippines with "pot money" awarded to the proclaimed winning entry;
5. **International Derby** – refers to any invitational cockfight participated in by local and foreign game cockers or cockfighting aficionados with pot money awarded to the proclaimed winning entry;
6. **Regular Games/Cockfighting** – held at designated cockpits arena usually on weekend featuring two fighting game cock;
7. **Pintakasi** – is a special three-day cockfighting event scheduled usually on weekdays with an intended charitable institution or group as beneficiary; and
8. **Derby** – Special Cockfighting event of an even bigger scale and participated in by big-time breeders.
9. **Bet taker/Promoter** – refers to a person who alone or with another initiates a cockfight and/or calls and take care of bets from owners of both gamecocks and those of other bettors before he orders commencement of the cockfight thereafter distributes won bets to the winners after deducting a certain commission, or both.

**SECTION 4: REGULATORY ACTS.**

1. Pursuant to Section 447 (3) (v) of the Local Government Code of 1991 otherwise known as the "Republic Act 7160" *"Any Law to the Contrary Notwithstanding, authorize and license the establishment, operation and maintenance of cockpits and regulate cockfighting and commercial breeding of gamecocks: Provided, That existing rights should not be prejudiced;"*

2. One cockpit for every 50,000 populations or fraction thereof shall be allowed to operate in the municipality of Bayabas, Surigao del Sur;

3. Imposition of Fees:

a. Application Filing Fee of P/ 200.00

Annual Cockpit Permit Fee of P/ 2,000.00

b. Aside from the license fee, the following derbies/cockfights fees are:

2 – Cock Derby/2 – wins	Php 1,000.00
3 – Cock Derby/3 - wins	Php 1,500.00
4 – Cock Derby/4 – wins	Php 2,000.00
5 – Cock Derby/5 - wins	Php 2,600.00
Special Cockfights (Pintakasi)	Php 600.00

c. Sultadas' fee at the following rate to the winning cock

Derby or Special Cockfights	Php 100.00

d. Fees of Cockpit Personnel

4. The annual cockpit permit fee is payable upon application of a permit before a cockpit shall be allowed to operate and within the first twenty days of January of each year in case of renewal thereof;

On derbies and special cockfights, the fees herein imposed shall be payable to the Municipal Treasurer before the same can be lawfully held;

5. Regular cockfights i. e., those held during Sundays, legal holidays, local fiestas and international derbies shall be excluded in the payment of fees herein imposed;

6. The permit fee for cockpit personnel shall be paid before they participate in a cockfight and pay annually upon renewal of the permit on the birth month of the permittee. Only duly registered and licensed personnel shall take part in all kinds of cockfights held in this Municipality. No operator or owner of a cockpit shall employ or allow to participate in a cockfight, any of the above-mentioned personnel unless he has registered and paid the fee herein required;
7. The franchise to operate a cockpit shall be granted by the Sangguniang Bayan of Bayabas, Surigao del Sur and shall be in effect for a period of three (3) years unless terminated by the Sangguniang Bayan for violation of the provision of this ordinance and related regulations. Present franchise holder will have the options to renew the franchise within 30 days after the expiration. Failure to file the renewal on the prescribed period will pass on the option to other applications. This is a requisite in the issuance of a Permit to operate from the Mayor's Office;
8. Vendors in the cockpit arena shall secure medical and sanitary permit/certificate before being allowed to engage business inside the cockpit arena;
8. Requirements for Application for Franchise.
  - a. New Applicants
    1. Registration of Business from either SEC or DTI
    2. Proof of Ownership of the Land or Lease Contract if being leased
    3. Proof of Financial Capacity, Company Profile Development Program and Project Impact Assessment
    4. Clearances (Barangay, Mayor's Clearance, DAR Clearance, HLURB and DENR)
    5. Land Reclassification if required (for Agricultural Land)
    6. Zoning Clearance and Building Permit
    7. Game Fowl Commission endorsement
  - b. For Renewal
    1. Clearances from the Treasurer's Office on Payment of Dues (Tax, RPT, etc.)
    2. New Lease Contract
    3. Audited Financial Statement
    4. Certification of the Municipal Engineer on the Worthiness of the Structure
    5. Sanitary and Health Clearance
    6. Fire safety Clearance
    7. No Cockpit shall be operated within the radius of 200 meters from school and other public buildings and churches.
    8. Aside from the operations of a cockpit all other business activities inside the premises of the cockpit will have to secure a Mayor's Permit relative to its operations and pay corresponding business taxes and Mayor's Permit Fees.

## **SECTION 5: CONDUCT OF COCKFIGHTING**

1. **Regular Cockfight** – Regular cockfight may be held only on Sundays and other legal holidays not unless restrained by national laws, decrees and promulgations.
2. **Pintakasi** – will be held twice a year at the most and applied with the Sangguniang Bayan fifteen (15) days before the activity and payment of corresponding fees before cockfight is held or in special cases, in excess of the allotted frequency will be approved as requested.
3. **Derby** – Derbies will only be allowed as pre-applied with the Sangguniang Bayan and will be approved through a resolution.
4. **Special Cockfights** – on request upon the approval of the Sangguniang Bayan.
5. There shall be a beneficiary for each derby and pintakasi of which, this shall not be less than 5% of the gross receipts.

#### **SECTION 6: PROHIBITIONS**

1. Selling and consumptions of liquor and other alcoholic beverages are prohibited within the premises of the cockpit arena;
2. Illegal gambling, such as "Tong its," other game cards, "Hantak," and others;
3. Carrying of deadly weapons, except for security personnel and military authorities;
4. Minors are strictly not allowed to enter and participate in the cockpit arena;
5. Smoking is strictly prohibited inside the cockpit arena, except in the designated smoking area;
6. Strictly no loitering policy shall be implemented within the cockpit arena and its immediate premises/surroundings, and as such, the management of the cockpit arena shall establish garbage management and disposal system in compliance to Republic Act No. 9003, otherwise known as "The Ecological Solid Waste Management Act of the Philippines."

**SECTION 7: PENAL PROVISIONS.** Violation of any provision of this ordinance shall have the following penalties:

First Offense	– two weeks suspension of the cockpit operations
Second Offense	– one month suspension of the cockpit operations
Third Offense	– Revocation of the Franchise

**SECTION 8: APPLICABILITY CLAUSE.** The provision of PD 449, otherwise known as the Cockfighting Law of 1974, PD1802 (Creating the Philippine Game Fowl Commission), and such other pertinent laws shall apply to all matters regarding the operation of cockpits in this Municipality.

**SECTION 9: SEPARABILITY CLAUSE.** If for any reason, any provision, section or part of this ordinance shall be held to be unconstitutional or invalid, other parts or provision thereof which are not affected shall continue be in full force and effect.

**SECTION 10: REPEALING CLAUSE.** All ordinances, resolutions (to include Resolution No. 52, Series of 2003), rules and regulations, or part thereof, whose provisions are in conflict


with, or contrary, to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 11: EFFECTIVITY CLAUSE.** This ordinance shall take effect upon approval of the Sangguniang Panlalawigan and posting of the same to conspicuous places in the municipality.

**AFFIRMING ORDINANCE NO. 11 DATED JUNE 21, 2017 OF THE MUNICIPALITY OF BAYABAS, THIS PROVINCE, ENTITLED "AN ORDINANCE PRESCRIBING GUIDELINES FOR THE GRANT OF AN AUTHORITY OR LICENSE TO OPERATE COCKPIT ARENA INCLUDING OTHER REGULATIONS RELATIVE THERETO", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Section 468, par. (a) No. 1 ( i ), Article III, Chapter 3 of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

**WHEREAS**, Ordinance No. 11 dated June 21, 2017 of the Municipality of Bayabas, this Province, entitled “An Ordinance Prescribing Guidelines for the Grant of an Authority or License to Operate Cockpit Arena Including Other Regulations Relative Thereto” was submitted to this Body for review and same was referred to the Committee on Laws and Justice and Human Rights for appropriate action;

**WHEREAS**, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the provisions of the Local Government Code of 1991;
