AFFIRMING ORDINANCE NO. 32 DATED SEPTEMBER 8, 2025 OF THE MUNICIPALITY OF CARRASCAL, THIS PROVINCE ENTITLED "AN ORDINANCE PROHIBITING MINORS FROM DRIVING MOTOR VEHICLES WITHIN THE MUNICIPALITY OF CARRASCAL, SURIGAO DEL SUR, PROVIDING PENALTIES FOR VIOLATION THEREOF, AND APPROPRIATING FUNDS FOR ITS IMPLEMENTATION", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 32 dated September 8, 2025 of the Municipality of Carrascal, this Province entitled "An Ordinance Prohibiting Minors from Driving Motor Vehicles Within the Municipality of Carrascal, Surigao del Sur, Providing Penalties for Violation Thereof, and Appropriating Funds for its Implementation", was submitted to this Body for review and same was referred to the Committee on Transportation, Traffic, Ports and Terminals, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 32 dated September 8, 2025 of the Municipality of Carrascal, this Province entitled "An Ordinance Prohibiting Minors from Driving Motor Vehicles Within the Municipality of Carrascal, Surigao del Sur, Providing Penalties for Violation Thereof, and Appropriating Funds for its Implementation", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such ordinance pursuant to the Local Government Code of 1991.
