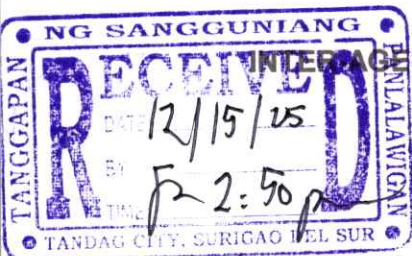

“REQUESTING THE PROVINCE OF SURIGAO DEL SUR TO ENJOIN THE CITY/MUNICIPAL LGU TO WAIVE ALL FORMS OF FEES AND PENALTIES FOR PURPOSES OF BIRTH REGISTRATION ASSISTANCE PROJECT BENEFICIARIES”

WHEREAS, the Inter-Agency Committee on Civil Registration and Vital Statistics: Surigao Del Sur was convened on 22 September 2022 to respond to the call of the national IACCRVS;

WHEREAS, the IACCRVS-Surigao del Sur will serve as the venue for discussion, issues, resolution and identify workable schemes towards the improvement of civil registration and vital statistics;

WHEREAS, the IACCRVS-Surigao del Sur is responsible in identifying strategies in order to meet the target under CRVS Goal 1. Universal civil registration of birth, death, and other vital events;

WHEREAS, Section 10 of Republic Act No. 11055 otherwise known as the “Philippine Identification System Act” provides that the basic documentary requirement for identification of citizens seeking to register with PhilSys is the applicant’s birth certificate;

WHEREAS, the PSA Memorandum Circular (MC) No. 2023-06 states, under the PhilSys Birth Registration Project (PBRAP) implemented by Philippine Statistics Authority (PSA) the requirements for late registration of birth were relaxed pursuant to the Operational Guidelines issued by the PSA through MC No. 2022-15 dated July 22, 2022;

WHEREAS, the PSA Memorandum Circular (MC) No. 2023-21, to attain 100 percent birth registration in the country and ensure all individuals have legal documentation, birth registration assistance will now become continuous project of the Philippine Statistics Authority-Civil Registration Service. With this, “PhilSys Birth Registration Assistance Project (PBRAP)” is now renamed into “Birth Registration Assistance Project (BRAP)”.

WHEREAS, Birth Registration Assistance Project aims to:

1. Ensure that all births of Filipinos are registered in the Local Civil Registry Offices; and
2. Increase the level of civil registration specially the marginalized communities such as those belonging to the Indigenous People, Muslim Filipinos and the poorest sector in the country and ensuring that they have their PhilIDs issued which is a gateway for them to claim their social benefits and legal identity.

WHEREAS, the IACCRVS-Surigao del Sur seeks to strengthen support of the Local Government Units (LGUs) in the province, specifically waiving all forms of fees and penalties for purposes of birth registration related to the project;

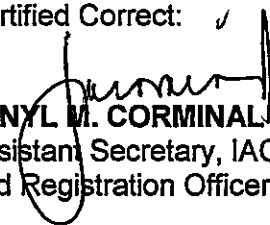

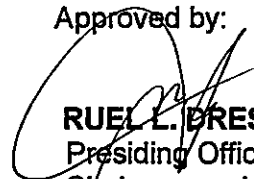
