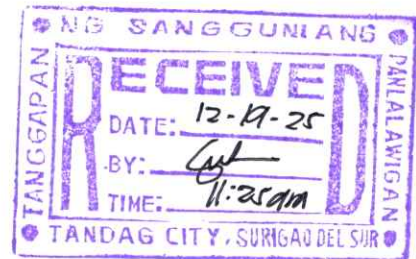

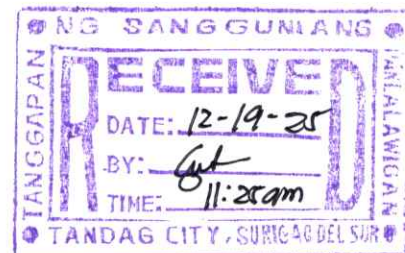

WHEREAS, the Municipal Development Council (MDC) of this municipality had formally endorsed to this august body its MDC Resolution No. 07-2025 requesting for the approval of the proposed reprogramming/reutilization of funds for projects under the 20% Local Development Fund (LDF) to another priority project of the Municipality in the amount of Three Million One Hundred Sixty Two Thousand Five Hundred Pesos (₱3,162,500.00).

NOW THEREFORE, be it ordained by the Sangguniang Bayan in its session duly assembled, that:

SECTION 1. TITLE. The title of this Ordinance shall be **“AN ORDINANCE AUTHORIZING THE REPROGRAMMING/REUTILIZATION OF FUNDS FOR PROJECTS INCORPORATED IN THE ANNUAL INVESTMENT PROGRAM F.Y. 2025 UNDER THE 20% LOCAL DEVELOPMENT FUND TO ANOTHER PRIORITY PROJECT IN THE AMOUNT OF THREE MILLION ONE HUNDRED SIXTY TWO THOUSAND FIVE HUNDRED PESOS (₱3,162,500.00)”**

SECTION 2. DECLARATION OF FUNDING SOURCE. The reprogrammed items shall be taken from the 20% Local Development Fund F.Y. 2025.

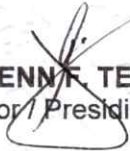
SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon its approval.

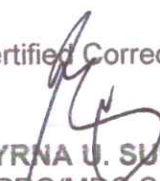

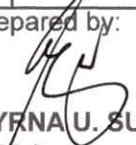
