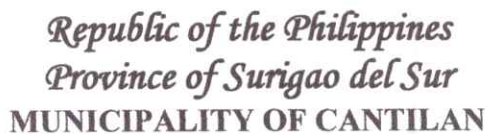

EXPLANATORY NOTE:

WHEREAS, the Barangay Council of Bugsukan recognizes the importance of rehabilitating the Multipurpose Building to ensure its continued use for community assemblies, emergency response, and the delivery of public services;

WHEREAS, with the availability of RCSP funds for health programs, the Barangay Council finds it necessary, practical, and appropriate to reprogram the said amount of **₱300,000.00** to the rehabilitation of the Multipurpose Building, which is equally vital to the welfare and development of the community;

BE IT ORDAINED by the Sangguniang Bayan of Cantilan, Surigao del Sur, in session assembled, that:

SECTION 1. REPROGRAMMING OF FUNDS. The amount of Three Hundred Thousand Pesos (₱300,000.00) from the 2025 Health Center budget is hereby reprogrammed and reallocated to the Rehabilitation of the Multipurpose Building of Barangay Bugsukan, Cantilan, Surigao del Sur.

SECTION 2. The Local Chief Executive, through the Engineering Office, is hereby authorized to implement the project, ensure the judicious and proper utilization of funds, and submit all required documents, including accomplishment reports, in accordance with existing laws, rules, and regulations.

SECTION 3. This ordinance shall take effect immediately upon approval.
