WHEREAS, Section 56 (a) of the Local Government Code of 1991 provides that, "within three (3) days after approval, the secretary to the sangguniang panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils";

WHEREAS, Resolution No. 2025-772 dated November 18, 2025 of the City of Bislig, this Province entitled "Resolution Approving the City Development Council Executive Committee (CDC-EXECOM) Resolution No. 12, Series of 2025, Entitled "Endorsing the Supplemental Annual Investment Program (AIP) No. 2 for Calendar Year (CY) 2026 of the City of Bislig", was submitted to this Body for review and same was referred to the Committees on Urban Planning and Development (Lead Committee)/Finance and Appropriation for appropriate action and was subsequently indorsed to the Provincial Planning and Development Office, for technical review;

WHEREAS, after the conduct of technical review, Ms. Vilma A. Ronquillo, EnP., Provincial Planning and Development Coordinator, this Province in her 2nd Endorsement dated December 11, 2025 returned to the August Body Resolution No. 2025-772 dated November 18, 2025, with the following remarks being recommended:

Based on the Article 410 IRR of R.A. 7160 the foregoing provision is clear on the following:

1. that the AIP shall be prepared and approved before the start of the Local budget preparation phase: and
2. that the Local Budgets shall Fund PPAs included in the AIP.
 - Item 3.7 of LBC No. 140 ^{amended} ~~is hereby amended~~, stated that in case the PPAs and expenses are not among those included in the approved AIP, the Local Development Council (LDC) shall prepare a Supplemental Investment Program for the purpose, to be approved by the Local Sanggunian;
 - Since the Annual Investment Program (AIP) for CY 2026 has not yet been approved, there is no legal basis for the formulation of a Supplemental Annual Investment Program (SAIP) CY 2026. Furthermore, as the AIP for CY 2026 has not yet been implemented, the term "Supplemental" is not applicable at this stage; and
 - Finally, it is ~~hereby~~ recommended that the Supplemental Annual Investment Program (SAIP) No. 2 be incorporated into and considered as part of the Annual Investment Program (AIP) for Calendar Year 2026.

WHEREAS, after a careful review by the Committees to which the matter was referred to, the Committees recommended to return Resolution No. 2025-772 dated November 18, 2025 of the City of Bislig, this Province entitled “Resolution Approving the City Development Council Executive Committee (CDC-EXECOM) Resolution No. 12, Series of 2025, Entitled “Endorsing the Supplemental Annual Investment Program (AIP) No. 2 for Calendar Year (CY) 2026 of the City of Bislig””, ~~for~~ taking into consideration the recommendations of the Provincial Planning and Development Office/Coordinator;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to return Resolution No. 2025-772 dated November 18, 2025 of the City of Bislig, this Province entitled “Resolution Approving the City Development Council Executive Committee (CDC-EXECOM) Resolution No. 12, Series of 2025, Entitled “Endorsing the Supplemental Annual Investment Program (AIP) No. 2 for Calendar Year (CY) 2026 of the City of Bislig””, ~~for incorporation~~ *with a recommendation that the same shall be* to the Annual Investment Program (AIP) for CY 2026.
