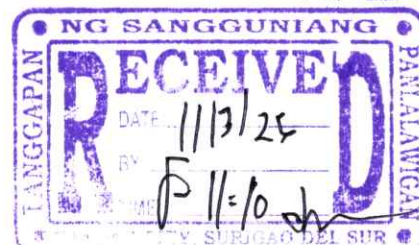

In no case shall the OWNER be liable for any loss, damage or injury that may arise by reason of the use and enjoyment of the fruits of said property by the USUFRUCTUARY.

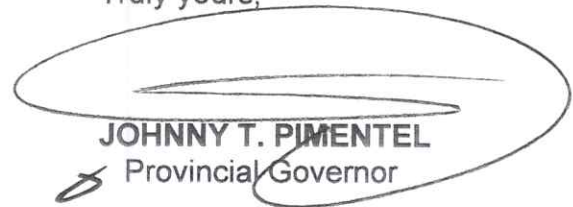
