Greetings from the PBMLP!


Attached herewith, is a letter addressed to the Honorable Vice-Governor, that Province, relative to the conduct of Provincial Representative to the PBMLP.

Dear Vice-Governor Alameda:

We all shared and experienced trekking the path towards winning the support of our communities.

Now, our collective passion to serve our constituents has just began!

As a League of public servants bound to serve our members and constituents, preparations for the forthcoming activities of the PBMLP have to start the, soonest.

In this regard, may we solicit the assistance of the Honorable Vice-Governor, to kindly take the initiative to cause the election of PBMLP Representative from among the Board Members, that Province, and submit to our office the results, through a resolution or any document to manifest that an election was held.

As such, the Representative-elect shall act as the liaison of the Provincial Board Members of that Province. This is consistent with Article X, Sec. 1, of the PBMLP Constitution and By-Laws, to read as follows:

"SECTION 1. The Provincial Board Members from each province shall elect from among themselves a Provincial Representative not later than Thirty (30) days from the assumption to office under a new term. The duly elected representatives shall act as the liaisons to the National Executive Board to the Provincial Board Members in their respective provinces with respect to the dissemination of information, project implementation, conduct of provincial PBMLP activities, and the collection of membership fees, term dues, and other assessments of the PBMLP. They may, from time to time, be required to attend meetings of the National Executive Board as deemed necessary, but do not have voting powers. They shall also sit as regular member of the Board of Directors in their respective Regional Assemblies."

The assistance of the Honorable Vice-Governor in this request is highly appreciated.
