AFFIRMING MUNICIPAL ORDINANCE NO. 03 DATED APRIL 14, 2025 OF THE MUNICIPALITY OF MADRID, THIS PROVINCE ENTITLED "AN ORDINANCE MANDATING THE CREATION OF SEPARATE AND DISTINCT BUDGETS FOR THE OFFICE OF THE VICE MAYOR, THE OFFICE OF THE SANGGUNIANG BAYAN MEMBERS, AND THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG BAYAN IN THE MUNICIPALITY OF MADRID, SURIGAO DEL SUR", IT BEING WITHIN SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Municipal Ordinance No. 03 dated April 14, 2025 of the Municipality of Madrid, this Province entitled "An Ordinance Mandating the Creation of Separate and Distinct Budgets for the Office of the Vice Mayor, the Office of the Sangguniang Bayan Members, and the Office of the Secretary to the Sangguniang Bayan in the Municipality of Madrid, Surigao del Sur", was submitted to this Body for review and same was referred to the Committee on Finance and Appropriation, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Municipal Ordinance No. 03 dated April 14, 2025 of the Municipality of Madrid, this Province entitled "An Ordinance Mandating the Creation of Separate and Distinct Budgets for the Office of the Vice Mayor, the Office of the Sangguniang Bayan Members, and the Office of the Secretary to the Sangguniang Bayan in the Municipality of Madrid, Surigao del Sur", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
