**AFFIRMING ORDINANCE NO. 012 DATED JUNE 04, 2025 OF THE CITY OF TANDAG, THIS PROVINCE ENTITLED "AN ORDINANCE REQUIRING ALL RESIDENTS, INSTITUTIONS, AND ESTABLISHMENTS IN THE CITY OF TANDAG TO MAINTAIN A 'GO BAG' OR 'SURVIVAL BAG' AS A MANDATORY COMPONENT OF DISASTER PREPAREDNESS, PROVIDING FOR IMPLEMENTATION GUIDELINES, AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**
