AFFIRMING ORDINANCE NO. 02 DATED JULY 7, 2025 OF THE MUNICIPALITY OF BAYABAS, THIS PROVINCE ENTITLED "AN ORDINANCE PROVIDING FREE FLUORIDE TREATMENT TO DAY CARE CHILDREN IN THE MUNICIPALITY OF BAYABAS, SURIGAO DEL SUR AND APPROPRIATING FUNDS THEREFORE", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 02 dated July 7, 2025 of the Municipality of Bayabas, this Province entitled "An Ordinance Providing Free Fluoride Treatment to Day Care Children in the Municipality of Bayabas, Surigao del Sur and Appropriating Funds Therefore", was submitted to this Body for review and same was referred to the Committee on Health, Sanitation and Nutrition, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
