WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor”;

WHEREAS, Ordinance No. 2025-09 dated June 10, 2025 of the City of Bislig, this Province entitled “An Ordinance Revising the Schedule of Wage Rate of Job Order and Contract of Service Employees of the City Government of Bislig, Effective January 1, 2026”, was submitted to this Body for review and same was referred to the Committee on Labor and Government Employment, for appropriate action;
