

RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON JOHNNY T. PIMENTEL, TO APPLY FOR A LOAN FROM THE LAND BANK OF THE PHILIPPINES TO FINANCE THE CONSTRUCTION OF THE THREE (3) STOREY CAPITOL BUILDING IN THE AMOUNT OF PHILIPPINE PESOS: TWO HUNDRED FIFTY MILLION ONLY (P250,000,000.00)

WHEREAS, Section 297 of R.A. 7160 (The Local Government Code of 1991) empowers all Local Government Units to contract loans, credits and other terms of indebtedness with any government or domestic bank to finance projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, Section 465, paragraph b.vi of the said R.A. 7160 empowers the Provincial Governor to represent the province in all its business transactions and sign in its behalf all bonds, contracts, obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to authorize, as he is hereby authorized, the Provincial Governor, Hon. Johnny T. Pimentel, to apply for a loan with the Land Bank of the Philippines to finance the construction of Three (3) Storey building in the amount of Philippine Pesos: Two Hundred Fifty Million Only (P 250,000,000.00).

RESOLVE, as it is hereby RESOLVED, to furnish the Land Bank of the Philippines and the Bureau of Local Government Finance (BLGF) with a copy of this Resolution.
