AFFIRMING ORDINANCE NO. 02 DATED JANUARY 27, 2026 OF THE MUNICIPALITY OF LIANGA, THIS PROVINCE ENTITLED "AMENDING SECTION 1 OF MUNICIPAL ORDINANCE NO. 03, SERIES OF 2023 ENTITLED 'AMENDING MUNICIPAL ORDINANCE NO. 02 SERIES OF 2011 RE: AN ORDINANCE AMENDING SECTION 6-D-01 OF THE MUNICIPAL REVENUE CODE INCREASING THE IMPOSITION OF EVERY PARKING CHARGES OF PUBS, PUJS, PU, VANS, BAO-BAO, TRICYCLES/MOTORCYCLES AND PRIVATE VEHICLES/CARS, DELIVER VANS AND CARGO TRUCKS WITHIN THE TERMINAL AND MARKET AREAS, POBLACION, LIANGA, SURIGAO DEL SUR', TO INCLUDE TERMINAL AND MARKET AREAS OF DIATAGON, THIS MUNICIPALITY", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 02 dated January 27, 2026 of the Municipality of Lianga, this Province entitled "Amending Section 1 of Municipal Ordinance No. 03, Series of 2023 Entitled 'Amending Municipal Ordinance No. 02 Series of 2011 Re: An Ordinance Amending Section 6-D-01 of the Municipal Revenue Code Increasing the Imposition of Every Parking Charges of PUBs, PUJs, PU, Vans, Bao-Bao, Tricycles/Motorcycles and Private Vehicles/Cars, Deliver Vans and Cargo Trucks Within the Terminal and Market areas, Poblacion, Lianga, Surigao del Sur', to Include Terminal and Market Areas of Diatagon, this Municipality", was submitted to this Body for review and same was referred to the Committee on Ways and Means and Taxation, for appropriate action;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 02 dated January 27, 2026 of the Municipality of Lianga, this Province entitled "Amending Section 1 of Municipal Ordinance No. 03, Series of 2023 Entitled 'Amending Municipal Ordinance No. 02 Series of 2011 Re: An Ordinance Amending Section 6-D-01 of the Municipal Revenue Code Increasing the Imposition of Every Parking Charges of PUBs, PUJs, PU, Vans, Bao-Bao, Tricycles/Motorcycles and Private Vehicles/Cars, Deliver Vans and Cargo Trucks Within the Terminal and Market areas, Poblacion, Lianga, Surigao del Sur', to Include Terminal and Market Areas of Diatagon, this Municipality", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
