

AFFIRMING RESOLUTION NO. 2026-048 DATED JANUARY 20, 2026 OF THE CITY OF BISLIG, THIS PROVINCE ENTITLED "RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE (CDC-EXECOM) RESOLUTION NO. 1, SERIES OF 2026, ENTITLED "ENDORING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 FOR CALENDAR YEAR (CY) 2026 OF THE CITY OF BISLIG AMOUNTING TO FIVE HUNDRED MILLION THREE HUNDRED THOUSAND PESOS (P500,300,000.00)", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN PANLUNGSOD CONCERNED PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991, SUBJECT TO VERIFICATION DURING THE SUBMISSION OF THE APPROPRIATION ORDINANCE TO ENSURE PLAN-BUDGET LINKAGE WHEREIN THE LOCAL BUDGETS TRULY OPERATIONALIZE APPROVED LOCAL DEVELOPMENT PLANS (SECTION 305 (i) R.A. 7160) AND ARE CONSISTENT WITH THE BUDGET OPERATIONS MANUAL (BOM) FOR LGUs 2023 EDITION

WHEREAS, Resolution No. 2026-048 dated January 20, 2026 of the City of Bislig, this Province entitled "Resolution Approving the City Development Council Executive Committee (CDC-ExeCom) Resolution No. 1, Series of 2026, Entitled "Endorsing the Supplemental Annual Investment Program (AIP) No. 3 for Calendar Year (CY) 2026 of the City of Bislig amounting to Five Hundred Million Three Hundred Thousand Pesos (P500,300,000.00)", was submitted to this Body for review and same was referred to the Committees on Urban Planning and Development (Lead Committee)/Finance and Appropriation and was subsequently indorsed to the Provincial Planning and Development Office, for technical review;

WHEREAS, after the conduct of technical review, Ms. Vilma A. Ronquillo, EnP., Provincial Planning and Development Coordinator, this Province in her 2nd Endorsement dated February 26, 2026 returned to the August Body Resolution No. 2026-048 dated January 20, 2026 of the City of Bislig, this Province for appropriate legislation with the information that the same is in order and in conformity with the prescribed guidelines and the provisions stipulated in the Department of Budget and Management – Department of Finance – Department of the Interior and Local Government (DBM-DOF-DILG) Joint Memorandum Circular No. 01 dated November 4, 2020 guidelines;
