WHEREAS, Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA), envisions to strengthen the agriculture and fisheries sector through modernization to attain food security, poverty alleviation, income enhancement and profitability, global competitiveness and sustainability;

WHEREAS, the Department of Agriculture - Regional Field Office No. 13 (DA-RFO 13) is the primary agency of the DA in the region and has the administrative and technical capability to effectively implement DA Mechanization Program particularly the provision of Agricultural Machinery, Facilities and Equipment;

WHEREAS, the "DA-RFO 13" is tasked and mandated to pursue agricultural development activities in Caraga Region in close coordination and cooperation with different Local Government Units (LGUs) and government agencies/organizations;

WHEREAS, the Provincial Government of Surigao del Sur is committed to strengthening its agricultural support services and enhancing post-harvest facilities to ensure the quality and safety of agricultural and fishery products in the province;

WHEREAS, Hon. Johnny T. Pimentel, Provincial Governor, this Province in his letter dated February 13, 2026 addressed to the 21st Sangguniang Panlalawigan thru Hon. Manuel O. Alameda, Sr., Vice Governor requested for a passage of a Sangguniang Panlalawigan Resolution authorizing the Provincial Governor to enter into and sign a Memorandum of Agreement (MOA), for and in behalf of the Provincial Government of Surigao del Sur, with the Department of Agriculture - Regional Field Office No. 13 (DA-RFO 13), represented by its Regional Executive Director, Engr. Ricardo M. Oñate Jr., for the said purpose;

WHEREAS, pursuant to Section 465 (1) (vi) of the Local Government Code of 1991, the Provincial Governor shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

Ricardo M. Oñate Jr., for the provision of one (1) unit Water Chiller to the Provincial Government of Surigao del Sur, provided that the parties mutually agree to the following terms and conditions, to wit:
