

AFFIRMING ORDINANCE NO. LP-02 DATED FEBRUARY 10, 2026 OF THE MUNICIPALITY OF TAGO, THIS PROVINCE ENTITLED "AN ORDINANCE ADOPTING THE NATIONAL AGRICULTURAL AND FISHERY COUNCIL (NAFC) GUIDELINES AND MANDATING THE CREATION, ORGANIZATION, AND ACTIVATION OF BARANGAY AGRICULTURAL AND FISHERY COUNCILS (BAFCS) IN ALL BARANGAYS OF THE MUNICIPALITY OF TAGO, SURIGAO DEL SUR", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. LP-02 dated February 10, 2026 of the Municipality of Tago, this Province entitled "An Ordinance Adopting the National Agricultural and Fishery Council (NAFC) Guidelines and Mandating the Creation, Organization, and Activation of Barangay Agricultural and Fishery Councils (BAFCs) in all Barangays of the Municipality of Tago, Surigao del Sur", was submitted to this Body for review and same was referred to the Committee on Agriculture/Fisheries (Lead Committee)/Barangay Affairs, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. LP-02 dated February 10, 2026 of the Municipality of Tago, this Province entitled "An Ordinance Adopting the National Agricultural and Fishery Council (NAFC) Guidelines and Mandating the Creation, Organization, and Activation of Barangay Agricultural and Fishery Councils (BAFCs) in all Barangays of the Municipality of Tago, Surigao del Sur", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
