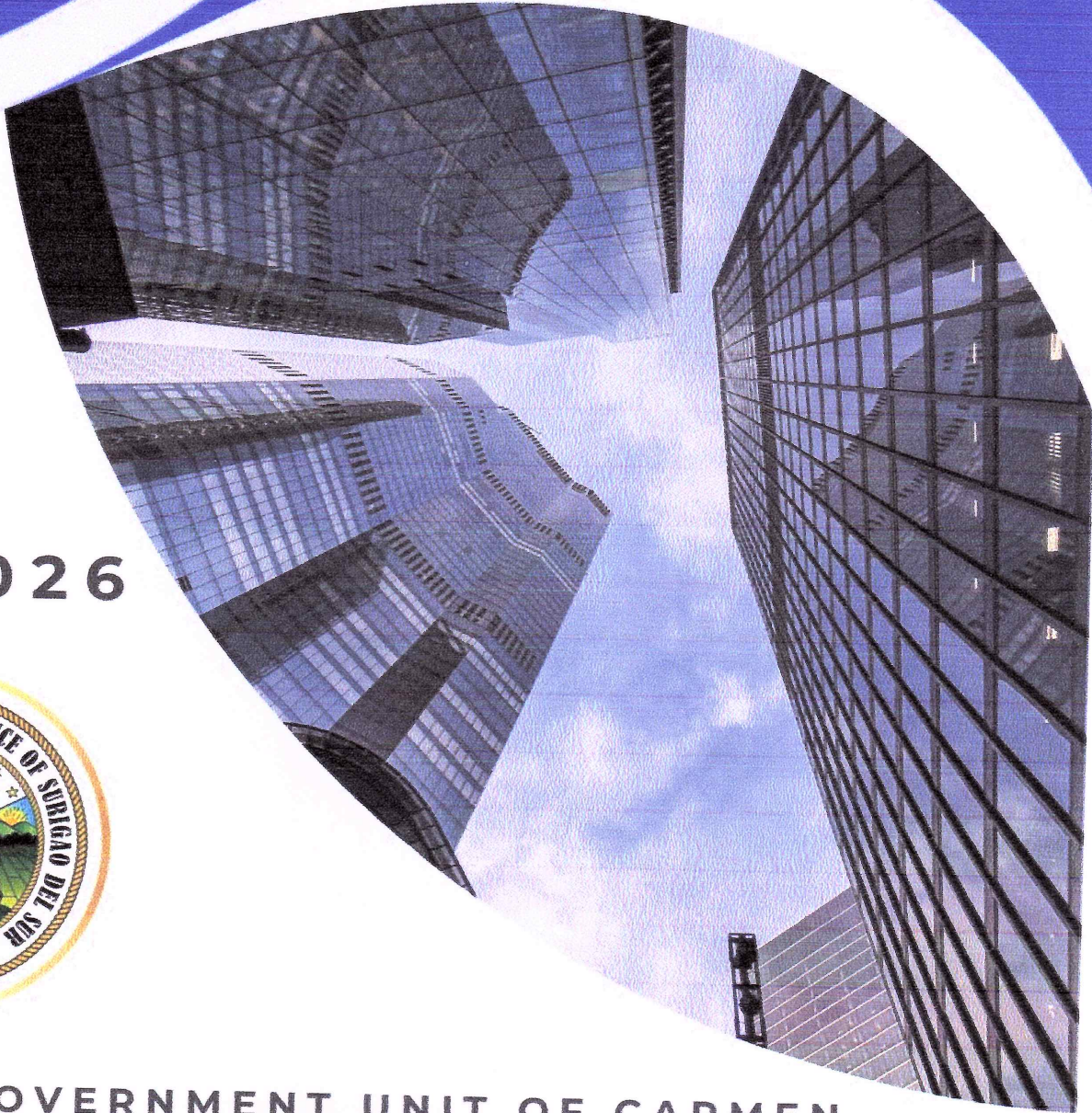

“INDORSING FAVORABLY TO THE HONORABLE MEMBERS OF THE SANGGUNIAN BAYAN OF THIS MUNICIPALITY THE HEREIN SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 02”

WHEREAS, evening of February 5, 2026 Tropical Storm Basyang enters the Philippine Area of Responsibility particularly in the Province of Surigao del Sur and severely affecting its municipalities including the Municipality of Carmen with the fast-rising floods coupled with strong currents causing landslides and soil erosions;

WHEREAS, the entire Province of Surigao del Sur was declared under a State of Calamity due to the impact of Tropical Storm Basyang thru Resolution No. 762-26, Series of 2026 dated February 9, 2026;

WHEREAS, the municipality reported major infrastructure damaged specifically the Hubason River Resort and Adventure Trail and the LGU sees the need to rehabilitate the resort;

WHEREAS, there is a need to allocate funds for the aforementioned rehabilitation, the source of which shall be taken from 20% Local Development Fund CY 2026 and Supplemental Budget No. 1 CY 2026;

WHEREAS, there is a need to reprogrammed from the original PPAs such as Development of Hubason River Resort and Adventure Trail (Phase II), and Hubason River Resort and Adventure Trail Operation to the proposed PPAs Climate-Resilient Site Development Plan and River Hydraulic & Hydrology (H&H) Study, and Rehabilitation of Hubason River Resort and Adventure Trail (HuRRAT) as detailed below;

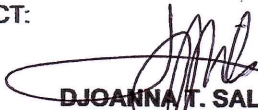

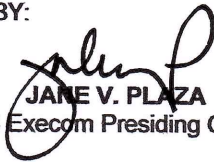
