AFFIRMING ORDINANCE NO. 23 DATED FEBRUARY 10, 2026 OF THE MUNICIPALITY OF CARMEN, THIS PROVINCE ENTITLED "AN ORDINANCE SUPPORTING THE INSTALLATION, OPERATION, MAINTENANCE AND MANAGEMENT OF CLOSED-CIRCUIT TELEVISION CAMERA (CCTV) IN STRATEGIC AREAS OF THE MUNICIPALITY OF CARMEN, PROVINCE OF SURIGAO DEL SUR, PROVIDING POLICIES, PRIVACY USE OF FOOTAGE, RESPONSIBLE ENTITIES, FUNDING AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 23 dated February 10, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Supporting the Installation, Operation, Maintenance and Management of Closed-Circuit Television Camera (CCCTV) in Strategic Areas of the Municipality of Carmen, Province of Surigao del Sur, Providing Policies, Privacy Use of Footage, Responsible Entities, Funding and for Other Purposes", was submitted to this Body for review and same was referred to the Committees on Peace and Order, Public Safety and Anti-Illegal Drugs (Lead Committee)/Social Service and Community Development, Differently Abled or Persons with Disabilities and Senior Citizens, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and jointly seconded by _____ and _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 23 dated February 10, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Supporting the Installation, Operation, Maintenance and Management of Closed-Circuit Television Camera (CCCTV) in Strategic Areas of the Municipality of Carmen, Province of Surigao del Sur, Providing Policies, Privacy Use of Footage, Responsible Entities, Funding and for Other Purposes", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
