WHEREAS, Awasian Road starting from the National Highway Crossing to Barangay Quezon is classified as a provincial road and in existence for more than sixty years;

WHEREAS, from time to date, said Provincial Road has not been provided/constructed of the drainage system necessary to ferry out storm and domestic water towards its outfall in Tandag River and/or the sea;

WHEREAS, along this Provincial Road and its vicinity are major infrastructure such as the City Hall Compound, Tandag Airport Compound, Vicente Pimentel National High School Compound, irrigation facilities, rice lands and several residential and commercial establishments;

WHEREAS, Barangays Awasian, Quezon, Bioto and San Agustin Sur are low-lying areas that easily become flooded during tropical depressions with moderate to heavy rainfall;

WHEREAS, the residents of Barangay Awasian had experienced one to two flooding each year and complained to this LGU their miserable condition of homes submerged under water and covered with silt thereafter causing personal belongings, appliances permanently damaged, crops and rice fields destroyed and of which one of the major causes is attributed to the absence of drainage canals along the Provincial Road and other flood mitigating infrastructure;

WHEREAS, on February 12, 2026 during the onslaught of Typhoon Basyang that hit this City, carrying torrential rain that caused rapid storm water accumulation, low lying homes of Barangays Awasian, Quezon, Bioto and San Agustin Sur experienced one of the worst conditions of flooding ever- homes being submerged underwater by as much as five feet deep and sweeping away personal belongings and things by the current of the rampaging flood water. As the flood water subsided, silt deposits in homes and rice fields were left as much as five inches thick, and sadly, most of the affected families have not fully recovered from their losses up to this time;

WHEREAS, this Sanggunian earnestly appeals to the good Governor Johnny T. Pimentel and to the honorable members of the Sangguniang Panlalawigan to prioritize funding allocation and commence construction of the drainage system of the Provincial Road to deter further destruction and miseries of its citizenry caused by flooding.
