

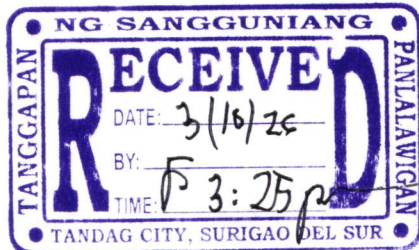

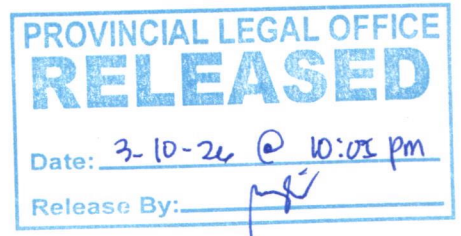

**EXECUTIVE ORDER NO. 2603 - 017**  
**Series of 2026**

**AN ORDER REORGANIZING THE MUNICIPAL LOCAL ZONING BOARD OF APPEALS (LZBA) OF THE MUNICIPALITY OF LANUZA**

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants local government units the power to enact zoning ordinances and to implement the same in their respective territorial jurisdictions;

**WHEREAS**, the Department of Human Settlements and Urban Development (DHSUD), formerly HLURB, provide the guidelines for the establishment of a Local Zoning Board of Appeals (LZBA) to hear and decide cases involving appeals, variances, exceptions, and interpretation for the Zoning Ordinance;

**WHEREAS**, there is a need to reorganize the Municipal Local Zoning Board of Appeals (LZBA) of the Municipality of Lanuza in order to effectively enforce the provisions of the Comprehensive Land Use Plan (CLUP) and the approved Zoning Ordinance of the municipality;

**WHEREAS**, for efficient coordination, documentation, and administrative support of the Board's proceedings, the Municipal Planning and Development Coordinator (MPDC) shall serve as the Secretariat of the Municipal Local Zoning Board of Appeals (LZBA);

**NOW, THEREFORE, I, ALGERICO H. IRIZARI, M.D.**, Municipal Mayor of Lanuza, Surigao del Sur, by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Local Zoning Board of Appeals (LZBA) of this municipality, to be composed of the following:

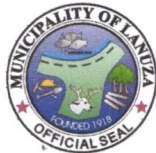

**SECTION 2. Functions**

The Local Zoning Board of Appeals shall:

1. Hear and decide appeals from the decision of the Zoning Administrator.
2. Act on applications for variances, exceptions, or special permits in accordance with the Zoning Ordinance.
3. Decide on complaints and questions of interpretation of the Zoning Ordinance.
4. Recommend to the Sangguniang Bayan appropriate amendments to the Zoning Ordinance, when necessary.

Perform such other functions as may be provided by law or ordinance.

**SECTION 3. Effectivity**

This Executive Order shall take effect immediately upon approval.
