WHEREAS, the Municipal Tree Park and Resort serve as a vital recreational and tourism destination that promotes environmental preservation, leisure, and local economic development;

WHEREAS, amendment of Section 2, (I) and repeal of (K) and (L) of Municipal Ordinance no. 11, Series of 2021, entitled: **AN ORDINANCE AMENDING SECTION 11 OF MUNICIPAL ORDINANCE NO. 03, SERIES OF 2001 ENTITLED: "AN ORDINANCE ESTABLISHING THE MUNICIPAL TREE PARK MANAGEMENT AND BASIC POLICIES FOR ITS OPERATION, IMPOSITION ON RENTAL RATES AND FEES AND FOR OTHE PURPOSES" BY INCREASING THE RENTAL RATES THEREOF AND OTHER FEES**", had been highly recommended to suit the present needs and operation of Marihatag Tree Park;

NOW THEREFORE

BE IT ORDAINED by the Sangguniang Bayan of Marihatag, Surigao del Sur, in session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be entitled as **"AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 11, SERIES OF 2021, ON THE PRESCRIBED FEES OF MARIHATAG TREE PARK AND RESORT SPECIFICALLY ON SECTION 2, LETTER (I.) ENTRANCE FEE, REPEALING (K) PARKING FEE, AND (L) CORKAGE FEE FOR RESTAURANTS AND EVENTS CATERED BY THE TREE PARK AND FOR OTHER PURPOSES THEREOF"** or **"Marihatag Tree Park Ordinance of 2026"**, as its short title.

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Municipality of Marihatag to promote sustainable tourism, protect the environment, and ensure the continuous development and improvement of the Municipal Tree Park and Resort through the collection of fair and reasonable fees and charges and other regulations for smooth operation of the same.

SECTION 3. COVERAGE. This Ordinance shall apply to all individuals, groups, organizations, and entities that will use, visit, rent, or avail of any facility or service within the Marihatag Tree Park and Resort premises.

SECTION 4. AMENDMENT OF SECTION 2 LETTER I. ENTRANCE FEE. Section 2 letter I of Municipal Ordinance no. 11, Series of 2021 shall be amended, as follows:

I. ENTRANCE FEE

I.1. NON-MARIHATAGNONS:

a. Children 7 years old and below	free
b. 8 years old and above	30.00
c. Senior Citizens/PWD	25.00

I.2. FOR MARIHATAGNONS, be it adult, children, senior citizens or PWDs, there shall be no entrance fees that will be required upon entering Marihatag Tree Park and Resort, **Provided That**, they shall not leave any garbage or wastes brought inside the resort but has to bring them back home or to deposit said garbage or wastes in the respective MRFs.

SECTION 5. PROVISION FOR FISHING AREA AND TIME. Fishing shall be allowed in the designated area identified by the Tree Park Manager. Fishing time shall be from 6:00 o'clock in the morning until 6:00 o'clock in the evening, daily.

SECTION 6. FREE USE OF AMENITIES FOR REGISTERED AND CHECKED-IN GUEST ONLY. Only duly registered and checked-in guests shall be entitled to the free use of the establishment's amenities. Registered and checked in guest shall refer to persons who have availed of and are occupying rooms in Marihatag Tree Park and Resort after completing the required registration and check-in process.

SECTION 7. LIFEGUARD AND ITS RESPONSIBILITIES. There shall be lifeguards that shall be stationed in the swimming areas that will be determined by the Tree Park Manager. Its duties and responsibilities are as follows:

1. Ensure the safety of swimmers and beach/pool users
2. Monitor the swimming area and enforce safety rules
3. Respond quickly to emergencies and perform rescues
4. Provide first aid and CPR when needed
5. Maintain cleanliness and readiness of rescue equipment
6. Other functions that may be required by the Municipal Mayor/Tree Park Manager.

SECTION 8. PROVISION OF PETTY CASH FUND. A petty cash fund in the amount of Two Hundred Thousand Pesos (P200,000.00) shall be allowed to ensure unhampered operations of Marihatag Tree Park and Resort. It shall be replenished in full upon liquidation to at least 75%. The Municipal Treasurer shall monitor, require immediate liquidation and or discontinue granting this fund If in her observation and findings, mishandling of said funds occurs.

SECTION 9. SECTION 2 – LETTERS K AND L. REPEALED. Section 2, letters (K) – PARKING FEE, and (L) – CORKAGE FEE FOR RESTAURANTS AND EVENTS CATERED BY THE TREE PARK are hereby expressed repealed.

SECTION 10. REPEALING CLAUSE All ordinances, resolutions, and executive issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 11. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall remain valid and enforceable.

SECTION 12. EFFECTIVITY CLAUSE. This Ordinance shall take effect after 15 days from posting of its copies in conspicuous places in the Municipality of Marihatag.

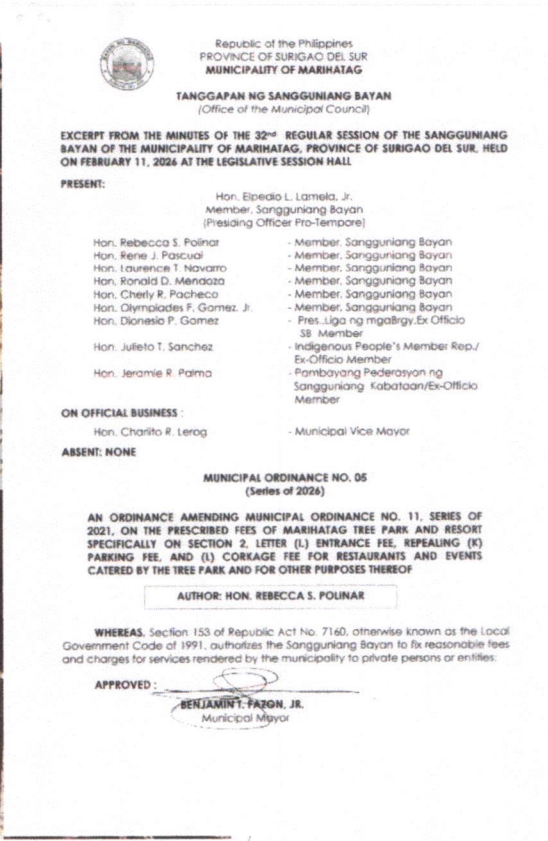
