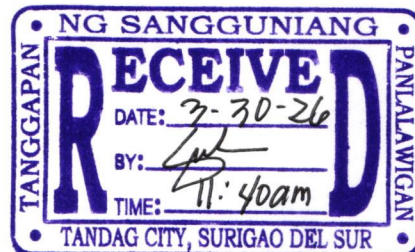

"AN ORDINANCE RENAMING OF PAYASAN ELEMENTARY SCHOOL TO GREGORIO R. PANTALEON ELEMENTARY SCHOOL OF BARANGAY PAYASAN, THIS LOCAL UNIT"

WHEREAS, Section 16 and 17, Title I of Republic Act No.7160, otherwise known as the Local Government Code of 1991, provides for the powers of the local government unit to exercise in promoting the general welfare and such other functions incidental and necessary to carry out the provisions on the basic services and facilities enumerated in the code;

WHEREAS, Section 13, Book 1, Title I, Chapter II of RA 7160, empowers the Sangguniang Bayan to change the name of municipal public schools within its territorial jurisdiction upon recommendation of the Local School Board concerned;

WHEREAS, DepEd Order No. 29, Series of 2011 provides for the revised guidelines on the renaming of public schools which further provides that renaming of school must have historical and cultural significance by the name being used and must contribute to the positive development of national pride through the good example exhibited by the name used;

WHEREAS, the Local School Board through Resolution No. 01, Series of 2026, recommends the renaming of Payasan Elementary School to Gregorio R. Pantaleon Elementary School;

WHEREAS, the Sangguniang Barangay of Payasan adopted Resolution No. 18 Series of 2025 dated September 5, 2025 strongly recommending the renaming of Payasan Elementary School to Gregorio R. Pantaleon Elementary School;

WHEREAS, the Parents Teachers Association of Payasan Elementary School issued PTA Resolution No. 02, series of 2025 dated August 28, 2025 which requests the Sangguniang Bayan of the Municipality of Lianga to change the name of Payasan Elementary School of the Schools Division of Surigao del Sur to Gregorio R. Pantaleon Elementary School;

WHEREAS, Payasan Elementary School is situated within the boundaries of Barangay San Pedro and Barangay Baucawe, Lianga, Surigao del Sur and had already produced high calibre professionals coming from both barangays;

WHEREAS, in appreciation of the generosity by donating 3,085 square meters as reflected in the Deed of Donation executed on May 20, 2021 of lot of the Pantaleon Family and in recognition of their contribution to the education sector, especially of their patriarch Gregorio R. Pantaleon;

NOW THEREFORE, on motion of Hon. Cynthia P. Sajot, Ph.D., duly seconded by Hon. Ignacio L. Serrano, Jr. and Hon. Maribeth M. Noval, be it:

ORDAINED by the Sangguniang Bayan in session assembled, that:

SECTION 1. RENAMING. Payasan Elementary School LOCATED BETWEEN THE BOUNDARIES of Barangay San Pedro and Barangay Baucawe, Lianga, Surigao del Sur is hereby renamed under the Schools Division of Surigao del Sur, District of Lianga, Surigao del Sur as **GREGORIO R. PANTALEON ELEMENTARY SCHOOL**;

SECTION 2. SUPPLEMENTAL FUNDS. All benefits such as construction, maintenance and operation previously granted to Payasan Elementary School shall now be retained by the renamed school. The supplemental funds as determined by the Local School Board shall be taken from the Special Education Funds of the Municipal Government of Lianga, Surigao del Sur.

SECTION 3. REPEALING CLAUSE. All Ordinance inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

SECTION 4. SEPARABILITY CLAUSE. Should any provision of this Ordinance be subsequently declared unconstitutional or invalid, the other provisions not affected by such declaration shall remain in full force and effect.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect fifteen (15) days from its approval upon posting in three (3) conspicuous places in the municipality.

- Prayer led by Hon. Segundina B. Urboda, Barangay Kagawad of Payasan
- Roll Call/Introduction of Participants by the Secretary to the Sanggunian
- Determination of Quorum by the presiding officer

Meeting Proper:

On her opening statement, presiding officer extended thanks and gratitude for positively answering the invitation. This pertains to the deed of donation made by the heirs of Gregorio R. Pantaleon in favor of the Department of Education – Payasan Elementary School and the heirs/owner has freely and voluntarily given, transferred and covered by way of donation.

Prior to the discussion, presiding officer requested the secretary to the sanggunian to present the legal basis as stipulated in the Local Government Code of 1991 and amended DepEd guidelines in renaming public schools.

Ma. Theresa C. Espuerta, *Principal-I of Payasan Elementary School*

- Last year of the month of October, attended a seminar and taking the chance of relating the issue on renaming of schools.
- Section 99(d) of RA 7160 (Local Government Code of 1991) authorizes the local sanggunian to change the name of schools through an ordinance, with the Local School Board as the recommending body.
- Approval by the Department Secretary on the naming and renaming of such schools is no longer necessary, pursuant to DepEd Order No. 29, Series of 2011 and that schools will not be renamed after the name of a living person and refrain of using the word "Memorial"
- DepEd Order No. 40, Series of 2014 issues the enclosed Revised Guidelines on the Establishment, Merging, Conversion and Naming/Renaming of Public Schools, and Separation of School Annexes in Basic Education which aims to provide comprehensive guidelines to streamline, synchronize and update the aforementioned work processes. The systems and procedures including the criteria set therein shall be used as guide by the DepEd Central and Field Offices/Units as well as the Department's external stakeholders to ensure that schools to be established, merged, converted, named/renamed are in accordance with DepEd quality standards to enhance the delivery of basic education.

Presiding Officer, Hon. Cynthia P. Sajot, Ph.D. asked the heir when will be the lapse of 5 years since the deed of donation was executed by both parties and that utmost consideration will be given in favor of the school anyway the process was then ongoing. Considering also the enacted ordinance will still be submitted to the sangguniang panlalawigan for affirmation.

- Gil L. Pantaleon responded that on May of this year will be the end as reflected on the Deed of Donation. The only thing they want is the name of the school to be renamed after their late father for legacy of his generosity and yet, the second party just taking it for granted without giving preferential attention to the agreement, but anyway, expressed out his absolute favor of its donation.

- Out of confusion whether or not DepEd Regional Office has given authority on the approval in renaming of public school, recommended to verify to the administrative officer of DepEd Region of its legality.

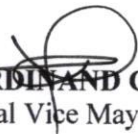
