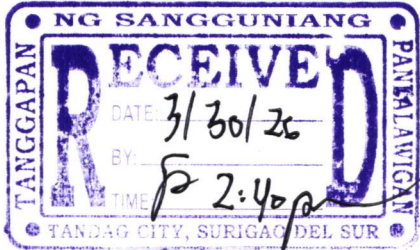

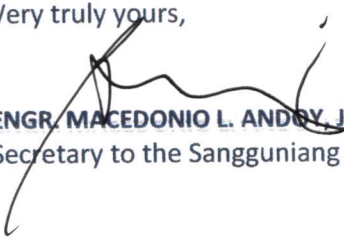

Prefatory Statements

WHEREAS, the conflict in the Middle East, particularly the war between the United States of America and Israel against Iran, has brought the ever-increasing prices of petroleum products to unprecedented levels, increasing prices of all commodities and consumer products;

WHEREAS, the said skyrocketing of prices of petroleum products greatly affected the transport sector, including the tricycle drivers and operators, prompting them to request the Municipal Government of Bayabas, Surigao del Sur to increase the fare rates, where Resolution No. 03, series of 2026 of the Bayabas Motor for Hire Association, was submitted to the Municipal Mayor for appropriate action, and the latter endorsed the same to this Sanggunian for possible legislation; and

WHEREAS, cognizant of the urgency of the request of the transport sector, taking into consideration as well as the effect on the commuting public, this Sanggunian hereby passes the amendment of the existing Provisional Fare Rate Matrix of this Municipality.

NOW, THEREFORE:

BE IT ENACTED, by the Sangguniang Bayan of Bayabas, Surigao del Sur, in session duly assembled, that:

 **SECTION 1.** Title. This Ordinance shall be known as “The New Provisional Fare Rate Ordinance for Tricycles” in the Municipality of Bayabas, Surigao del Sur.

SECTION 2. Scope and Coverage. As a guide for drivers and commuters, this Ordinance shall cover all tricycles, which include the traditional make and the “Bao-Bao” granted with the appropriate franchise to operate from this Local Government Unit (LGU), and other passenger vehicles authorized by the Land Transportation Office (LTO) operating within the territorial jurisdiction of the Municipality of Bayabas, Surigao del Sur.

SECTION 3. Provisional Fare Rates. In view of the urgency of the situation, where the prices of petroleum products continue to rise due to the Middle East conflict, the provisional fare rate matrix prescribed under Ordinance No. 13, Series of 2022, shall be increased by ₱5.00 only. The new Provisional Fare Rate Matrix is as follows:

SECTION 4. Application of the Provisional Fare Rates shall be observed in accordance with Section 9, (C), (3) and Section 20 of Ordinance No. 10, series of 2020, otherwise known as the New Transportation Code of the Municipality of Bayabas, Surigao del Sur.

SECTION 5. Roll Back. If the prices of petroleum products return to their normal level, or are stabilized, this New Provisional Fare Rate Matrix shall be rolled back to the levels prescribed under Ordinance No. 13, Series of 2022.

SECTION 6. Penalty. For any violation of the provisions under Section 3 of this Ordinance, the penalty provisions under Ordinance No. 13, Series of 2022, shall apply.

SECTION 7. Repealing Clause. Any ordinances, executive orders, and local issuances, rules and regulations, or parts thereof, inconsistent with or in conflict with this ordinance are hereby repealed and or modified accordingly.

SECTION 8. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, the other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 9. Effectivity Clause. This ordinance shall take effect immediately, considering its urgency; however, posting shall still be done for ten (10) days from the date of its approval in the bulletin board at the entrance of the Municipal Building and in 2 conspicuous places within the Municipality.

ENACTED this 23rd day of March, 2026, at Bayabas, Surigao del Sur, upon motion of Hon. Louime Z. Maglangit, duly seconded by all Sangguniang Bayan Members present, there being a quorum.

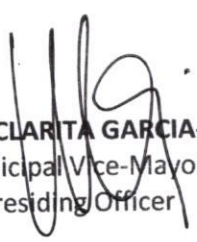

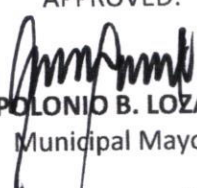

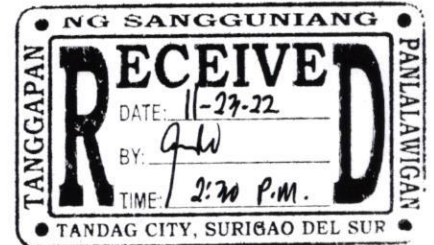

AN ORDINANCE PROVIDING FOR THE PROVISIONAL FARE RATES FOR TRICYCLE AND MOTORCYCLE-TAXI OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BAYABAS, SURIGAO DEL SUR AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

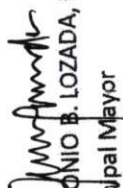

BE IT ENACTED, by the Sangguniang Bayan of Bayabas, Surigao del Sur is session duly assembled, that:

SECTION 1. Title. This Ordinance shall be known as "Provisional Fare Rate Ordinance for Tricycle and Motorcycle-Taxi."

SECTION 2. Scope and Coverage. As a guide for drivers and commuters, this Ordinance shall cover all tricycles, motorcycle-taxis with Special Permit from this Local Government Unit (LGU), and other passenger vehicles authorized by the Land Transportation Office (LTO) operating within the territorial jurisdiction of the Municipality of Bayabas, Surigao del Sur.

SECTION 3. Provisional Fare Rates. Drivers of tricycles, motorcycle-taxis, and passenger vehicles shall only collect fares from their passengers according to the Fare Rate Matrix prescribed by the Bayabas Land Transportation Franchise and Regulatory Board (BLTFRB) and adopted and approved by the

SECTION 4. Application of the Provisional Fare Rates shall be observed in accordance to Section 9, (C), (3) and Section 20 of Ordinance No. 10, series of 2020, otherwise known as the New Transportation Code of the Municipality of Bayabas, Surigao del Sur.

SECTION 5. Penalty. Any violation of the provisions under Section 3 of this Ordinance shall be fined ₱ 2,500 or imprisonment of not more than six (6) months at the discretion of the court.

SECTION 6. Repealing Clause. Any ordinances, executive orders and local issuances, rules and regulations, or parts thereof, inconsistent with or in conflict with this ordinance are hereby repealed and or modified accordingly.

SECTION 7. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, the other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 14. Effectivity. This ordinance shall take effect after ten (10) days from the date a copy hereof is posted in the bulletin board at the entrance of the municipal building of Bayabas, Surigao del Sur and in at least two (2) conspicuous places in the municipality.

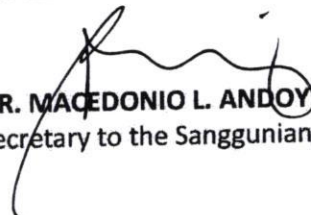

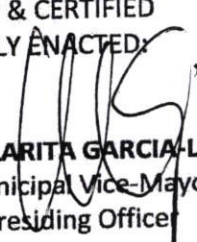

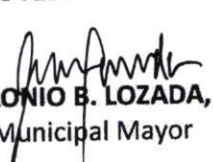
