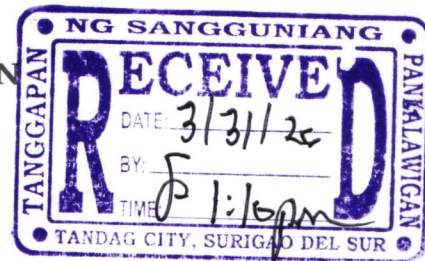

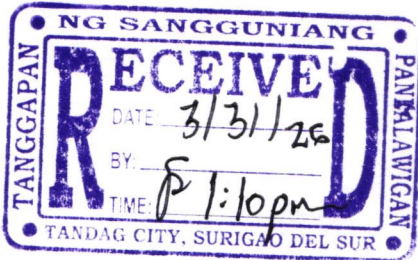
INSTITUTIONALIZING THE "BIRTHDAY CAKE PROGRAM" FOR ALL SENIOR CITIZENS OF THE MUNICIPALITY OF HINATUAN, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES

NOW THEREFORE;

BE IT ORDAINED, by the Sangguniang Bayan of Hinatuan, in session duly assembled, that:

Section 1. Title. This ordinance shall be known as the "SENIOR CITIZENS BIRTHDAY CAKE PROGRAM ORDINANCE OF THE MUNICIPALITY OF HINATUAN."

Section 2. Declaration of Policy. It is hereby declared the policy of the Municipality of Hinatuan to recognize, honor, and show appreciation to its senior citizens by giving them importance during their birthdays through the provision of a birthday cake as a gesture of love, respect, and gratitude for their invaluable contribution to family, community, and society.

Section 3. Coverage. This ordinance shall apply to all registered senior citizens of the Municipality of Hinatuan, duly recognized and certified by the Office of the Senior Citizens Affairs (OSCA), who are seventy (70) years old and above.

Section 4. Benefit. Every qualified senior citizen shall receive one (1) birthday cake on the occasion of his/her birthday, to be delivered by the Municipal Government through the OSCA, in coordination with the Municipal Social Welfare and Development Office (MSWDO).

Section 5. Implementation.

a. The Office of the Senior Citizens Affairs (OSCA), in coordination with the MSWDO, shall maintain a registry of senior citizens' birthdays for proper scheduling and delivery.

b. The Municipal Mayor's Office shall ensure the effective implementation of the program.

c. The distribution of birthday cakes shall be done either at the residence of the celebrant or at the OSCA office, depending on arrangements.

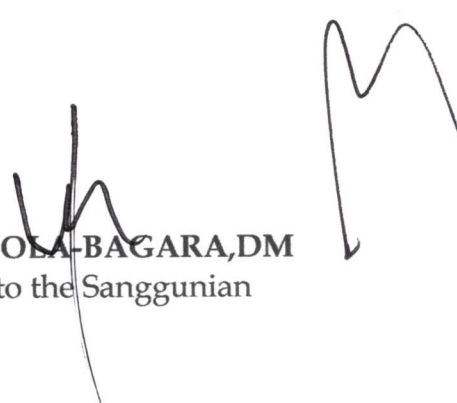
Section 6. Appropriations. The necessary funds for the implementation of this ordinance shall be charged to the Annual Budget of the Municipality of Hinatuan under the Social Services Fund. Supplemental funds may be sourced from other lawful means as the need arises.

Section 7. Separability Clause. If any part or provision of this ordinance shall be declared unconstitutional or invalid, the other parts not affected shall remain valid and enforceable.

Section 8. Repealing Clause. All ordinances, resolutions, rules, and regulations inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 7. Effectivity Clause - That this ordinance shall take effect immediately upon approval by the Local Chief Executive (Sec. 54, RA 7160) and posting the same.

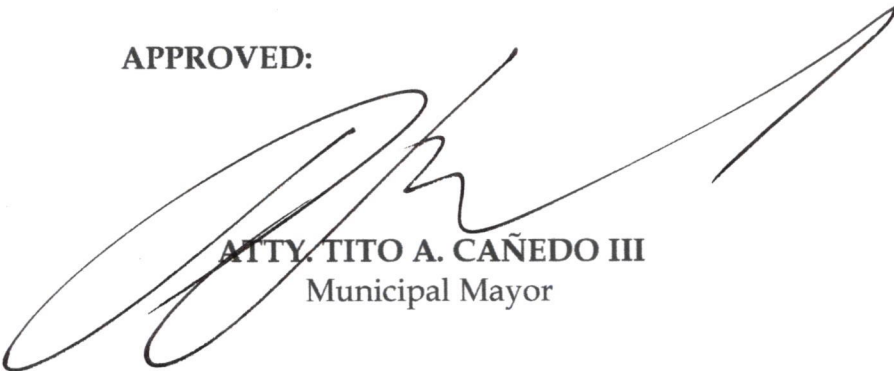
