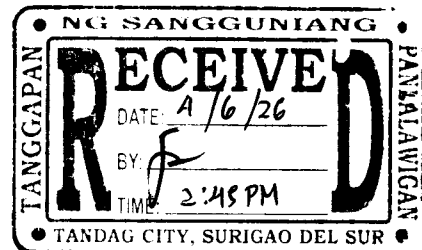

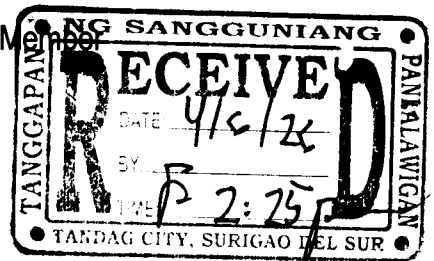

BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Lanuza, Surigao del Sur, in session assembled, that:

SECTION 1. DECLARATION OF POLICY - It is hereby declared that all financial donations received by the Local Government Unit of Lanuza in relation to Tropical Storm Basyang, although treated as trust funds, it is construed as government funds and therefore utilization and disbursement shall be in accordance to Section 305 of Republic Act No. 7160 provides that “no money shall be paid out of the local treasury except in pursuance of an appropriation ordinance or law, Local government funds and monies shall be spent solely for public purposes, and All monies officially received by a local government officer in any capacity or on any occasion shall be accounted for as local funds, unless otherwise provided by law;

SECTION 2. SOURCE OF FUNDS - The Municipality of Lanuza has received financial donations from various donors intended to support relief operations and rehabilitation efforts for affected constituents, which shall be utilized in accordance with applicable laws, rules, and regulations in the amount of Two Million Forty-Four Thousand Four Hundred Ninety-Two Pesos and Seventy Centavos (P2,044,492.70).

SECTION 3. AUTHORIZATION- SECTION — Pursuant to this Ordinance, the utilization and disbursement of the financial donations herein reported and specified as received by the Local Government Unit of Lanuza are hereby authorized solely for the purpose of supporting relief and rehabilitation efforts in response to Tropical Storm Basyang, subject to existing laws, rules, and regulations.

SECTION 4. ALLOCATION OF FUNDS - The amount of Two Million Forty-Four Thousand Four Hundred Ninety-Two Pesos and Seventy Centavos (₱2,044,492.70) shall be allocated as follows:

- **₱1,500,000.00** – for fuel oil and lubricant expenses to support relief operations, clearing, transportation, and rehabilitation activities;
- **₱544,492.70.00** – for the procurement of construction materials necessary for the repair and rehabilitation of damaged infrastructure and facilities.

Total Expenditure: ₱2,044,492.70

SECTION 5. IMPLEMENTATION - The Municipal Mayor, the Municipal Treasurer, and the Municipal Accountant are hereby authorized to ensure the proper utilization and disbursement of the funds in accordance with existing accounting and auditing laws, rules, and regulations.

SECTION 6. TRANSPARENCY AND ACCOUNTABILITY - All expenditures shall be subject to existing government accounting and auditing laws, rules, and regulations, and shall be properly recorded and supported by appropriate documentation to ensure transparency and accountability in the use of public funds.

The Municipal Development Council (MDC) shall monitor the utilization and disbursement of the funds, in coordination with the Municipal Disaster Risk Reduction and Management Council (MDRRMC).

SECTION 7. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in full force and effect.

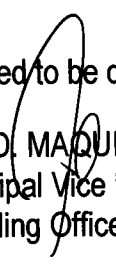
SECTION 8. EFFECTIVITY - This Ordinance shall take effect immediately upon approval.

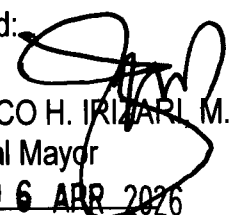
