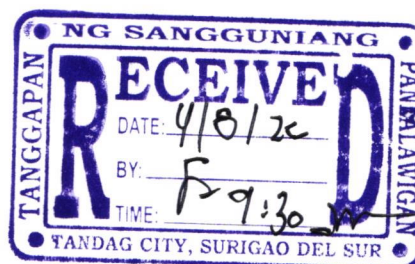

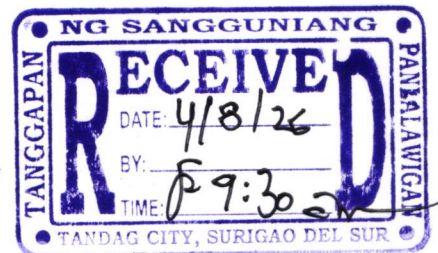

AN ORDINANCE GRANTING A MONTHLY HONORARIUM OF P500.00 TO THE CHILD PROTECTION AND STRATEGIC HELPDESKS FOR INFORMATION, EDUCATION, LIVELIHOOD, AND OTHER DEVELOPMENT (SHIELD) INTERVENTION AGAINST CHILD LABOR HELP DESK OFFICERS IN EVERY BARANGAY OF THE MUNICIPALITY OF SAN MIGUEL, SURIGAO DEL SUR.

Explanatory Note

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall promote the general welfare, including the protection of children and the promotion of their rights and well-being;

WHEREAS, Republic Act No. 7610, otherwise known as the Special Protection of Children Against Abuse, Exploitation and Discrimination Act, mandates the State and local government units to provide protection to children against child labor and other forms of abuse;

WHEREAS, Republic Act No. 9231, also known as the Elimination of the Worst Forms of Child Labor Act, requires government agencies and local government units to implement programs to eliminate child labor;

WHEREAS, the Department of Labor and Employment (DOLE) and the Department of Social Welfare and Development (DSWD) encourage the establishment of Child Protection and SHIELD (Strategic Helpdesks for Information, Education, Livelihood, and Other Development) Intervention Against Child Labor Help Desks at the barangay level;

WHEREAS, the Help Desk Officers in every barangay play a vital role in monitoring, reporting, and assisting in the implementation of programs against child labor and in the protection of children;

WHEREAS, the grant of a monthly honorarium will serve as support and recognition for the services rendered by the Help Desk Officers in the performance of their duties;

WHEREAS, the Municipality has available funds subject to existing budgeting, accounting, and auditing rules and regulations;

NOW THEREFORE

Be it ordained by the Sangguniang Bayan of the Municipality of San Miguel, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the “Ordinance Granting Monthly Honorarium to SHIELD / Child Labor Help Desk Officers in Every Barangay of San Miguel, Surigao del Sur.”

SECTION 2. COVERAGE. This Ordinance shall cover all duly designated Child Protection and SHIELD Intervention Against Child Labor Help Desk Officers in every barangay of the Municipality of San Miguel, Surigao del Sur.

SECTION 3. GRANT OF HONORARIUM. Each Help Desk Officer shall receive a monthly honorarium of Five Hundred Pesos (P500.00) subject to the availability of funds and compliance with existing government accounting and auditing rules and regulations.

SECTION 4. SOURCE OF FUND. Funds necessary for the implementation of this Ordinance shall be charged against available funds of the Municipality and shall thereafter be included in the annual budget subject to existing budgeting, accounting, and auditing rules and regulations.

SECTION 5. IMPLEMENTING OFFICE. The Municipal Social Welfare and Development Office (MSWDO), in coordination with the Municipal Budget Office, Municipal Treasurer, and Municipal Accountant, shall implement the provisions of this Ordinance.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall not be affected.

SECTION 7. EFFECTIVITY. This Ordinance shall take effect upon approval and after compliance with all required legal procedures.
