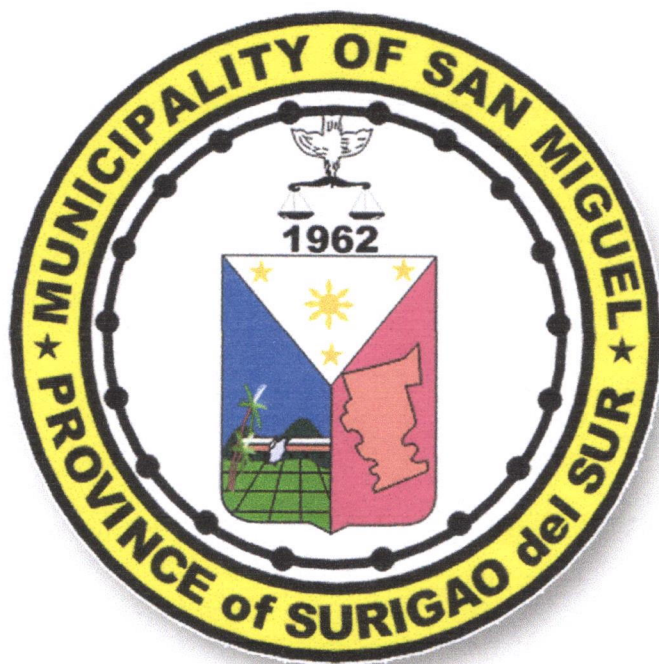

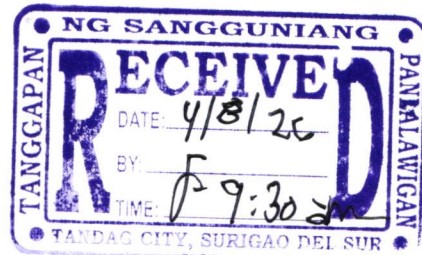

AN ORDINANCE GRANTING A MONTHLY SUBSIDY IN THE AMOUNT OF FIVE HUNDRED PESOS (PHP 500.00) TO REGISTERED PERSONS WITH DISABILITIES (PWDs) WHO ARE BEDRIDDEN IN THE MUNICIPALITY OF SAN MIGUEL, PROVINCE OF SURIGAO DEL SUR, EFFECTIVE JANUARY 2026.

Explanatory Note

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to promote the general welfare and enhance the quality of life of their constituents, particularly the marginalized and vulnerable sectors of society;

WHEREAS, Republic Act No. 7277, otherwise known as the Magna Carta for Persons with Disabilities, as amended by Republic Act Nos. 9442 and 10754, recognizes the rights of Persons with Disabilities (PWDs) to social protection, assistance, and programs that promote their welfare and dignity;

WHEREAS, bedridden Persons with Disabilities are among the most vulnerable sectors, requiring continuous medical care, assistance, and financial support for their daily needs;

WHEREAS, the Municipal Government of San Miguel recognizes the need to provide direct financial assistance to registered bedridden PWDs to help alleviate their financial burden and support their basic and medical needs;

WHEREAS, the granting of a monthly subsidy will complement existing social welfare programs of the Municipality and contribute to the protection and well-being of bedridden PWDs;

NOW THEREFORE

Be it ordained by the Sangguniang Bayan of the Municipality of San Miguel, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Bedridden Persons with Disability Monthly Subsidy Ordinance of San Miguel, Surigao del Sur."

SECTION 2. COVERAGE. This Ordinance shall cover all registered Persons with Disabilities (PWDs) who are bedridden, residents of the Municipality of San Miguel, Surigao del Sur, and duly certified by the Persons with Disability Affairs Office (PDAO) and the Municipal Social Welfare and Development Office (MSWDO).

SECTION 3. GRANT OF MONTHLY SUBSIDY. All qualified beneficiaries shall receive a monthly subsidy of Five Hundred Pesos (P500.00) effective January 2026, subject to availability of funds and compliance with government accounting and auditing rules.

SECTION 4. QUALIFICATION. To qualify, the beneficiary must:

- I. Be a registered PWD of the Municipality;
- II. Be medically certified as bedridden by a government physician or authorized health officer;
- III. Be listed and validated by the PDAO / MSWDO;
- IV. Be a resident of San Miguel, Surigao del Sur.

SECTION 5. SOURCE OF FUND. Funds necessary for the implementation of this Ordinance shall be charged against available funds of the Municipality and shall thereafter be included in the annual budget subject to existing budgeting, accounting, and auditing rules and regulations.

SECTION 6. IMPLEMENTING OFFICE. The Persons with Disability Affairs Office (PDAO) in coordination with the Municipal Social Welfare and Development Office, Municipal Budget Office, Municipal Treasurer, and Municipal Accountant, shall implement the provisions of this Ordinance.

SECTION 7. MONITORING AND VALIDATION. The PDAO and MSWDO shall maintain an updated list of beneficiaries and ensure that only qualified recipients receive the subsidy.

SECTION 8. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 9. EFFECTIVITY. This Ordinance shall take effect upon approval and after compliance with all required legal procedures.

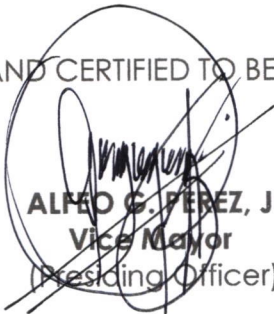
