

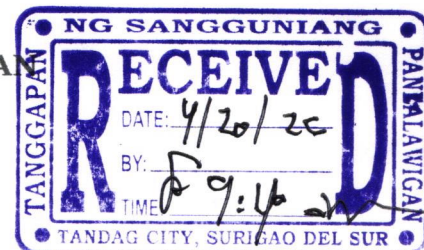

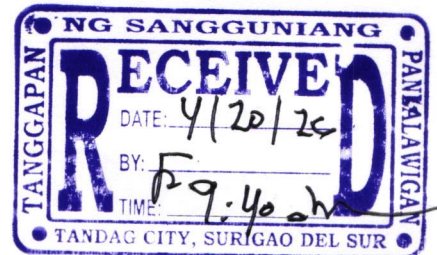

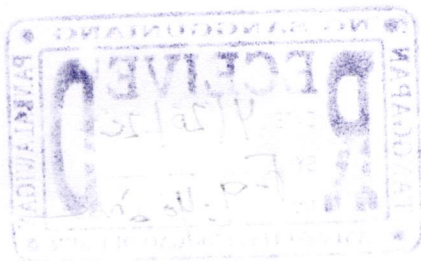

Be it ordained by the Honorable Sangguniang Bayan, in session assembled and by authority of the same, that:

WHEREAS, this Sangguniang Bayan (SB) issued Resolution No. CG-123 dated September 23, 2025 authorizing the Honorable Mayor to negotiate and contract a loan with the Land Bank of the Philippines to finance the following projects:

A. TERM LOAN 1

Purpose	Amount
To finance the design and build of the proposed Enchanted River Hotel including complete detailed engineering plans and design of the structures such as function hall, bar and restaurant, swimming pool, sports facilities , landscaping and walkways, staff quarter, guard house, perimeter fence.	Php. 140,000,000.00

B. TERM LOAN 2

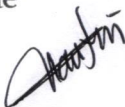
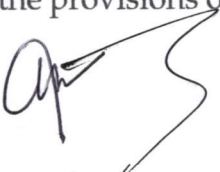
Purpose	Amount
To finance acquisition of the proposed Enchanted River Hotel’s furniture and fixtures, utensils, textiles, power and water supplies, generator set, air conditioning system, CCTV and communication equipment, water and waste treatment facilities.	Php. 60,000,000.00

C. TERM LOAN 3

Purpose	Amount
To finance the acquisition of various brand new heavy equipment.	Php. 100,000,000.00

WHEREAS, the loan application of the Municipality was duly approved by the Land Bank of the Philippines, which was formally communicated through a Notice of Loan Approval dated January 30, 2026.

WHEREAS, there is a need for this SB to review, approve, confirm and ratify the approved terms and conditions of the aforementioned loan and, if found satisfactory, to approve the same through an ordinance, consistent with the provisions of RA. 7160 or The Local Government Code;



WHEREAS, upon review, this SB finds the approved terms and conditions of the loan to be satisfactory, fair, reasonable and advantageous to the Municipality;

NOW THEREFORE;

Section 1. The terms and conditions of the approved loan with the Land Bank of the Philippines, as contained in the Notice of Loan Approval dated January 30, 2026 and the draft of the Loan Agreement attached herewith as Annexes A and B and are now made integral parts hereto, **are hereby approved, confirmed and ratified;**

Section 2. The Municipality Government of Hinatuan through its incumbent Mayor, Honorable Atty. Tito A. Cañedo III his successors and assigns, is hereby authorized and empowered, for and in behalf of this Municipality, to sign, execute, endorse and deliver any and all agreements, promissory notes, deed of assignments and other documents and deeds as may be necessary and proper for the implementation of the loan and the authorities and directives contained in this ordinance,

Section 3. As security/collateral to the loan obtained, the assignment of twenty percent (20%) of this Municipality's Internal Revenue Allotment (IRA) and/or National Tax Allotment (NTA) and other revenues, incomes and collections in favor of the Land

Bank of the Philippines, which are hereby declared to be available and not restricted by law or other obligations, is hereby authorized,

Section 4. In acknowledgment of this Municipality's loan with Land Bank of the Philippines, the Municipal Treasurer and Accountant are hereby directed to enter in the Municipality's book of accounts the said loan at its contractual obligation;

Section 5. The Municipal Government of Hinatuan Surigao del Sur, hereby designates Land Bank of the Philippines as its major depository bank for all its local revenues, fees and collections, and this designation shall not be revoked or changed for as long as any portion of the loan herein authorized, including interests and other charges due thereon, remain outstanding;

Section 6. Provisions for continuing appropriation, and submit consequent annual certifications thereto to LANDBANK, in the Municipality's Annual Budget for the following is hereby authorized:

6.1. loan repayment until the principal, interest and other charges are fully paid

6.2. the required equity of the Municipality to the projects

6.3. repairs, maintenance and insurance premium for the projects

6.4. other statutory and contractual obligations,



Section 7. The Municipality hereby authorizes Land Bank of the Philippines to debit/deduct for set-off amounts from any deposits or funds of the Municipality with LANDBANK and apply the same for the payment of the loans or any portion thereof, and interests and penalties thereon, including insurance premiums, as may be deemed necessary by LANDBANK;

Section 8. The Municipality hereby commits not to contract other loans or credits with other banks or creditors that would impair its paying capacity for the duration of the loan's with LANDBANK;

Section 9. The Municipality hereby waives its rights under applicable laws on bank secrecy and information security existing or may hereafter be enacted, such as Republic Act (R.A.) No. 1405 (The Law on Secrecy of Bank Deposits), RA 6426 (Foreign Currency Deposit Act), R.A. 8791 (The General Banking Law), RA 10173 (Data Privacy Act), and authorizes LANDBANK: (a) pursuant to BSP Circular No. 472 Series of 2005, as amended, and as implemented by BIR Revenue Regulation RR 4-2005, to verify with the Bureau of Internal Revenue (BIR) (or such other taxing authority that may substitute it) in order to establish authenticity of the annual income tax returns and accompanying financial statements and documents or information submitted by the Municipality, (b) to inquire into any of the deposit accounts or properties maintained by the Municipality with LANDBANK for the purpose of implementing the Automatic Debit Authorization or set-off provisions, and (c) obtain from or disclose to credit bureau any information regarding the Municipality as LANDBANK may deem necessary to exercise its rights under the Loan Agreement or may be allowed or required by applicable laws, rules and regulations. The Municipality also hereby authorizes LANDBANK to request information on the status of any court case to which the Municipality is a party. Pursuant to RA 9510 (Credit Information System Act), the Municipality finally authorizes the submission of basic credit data in connection with any credit availment from LANDBANK to the Credit Information Corporation (or its successor entity) and authorizes the latter to provide the same information to the BSP;

Section 10. All previous representations and warranties not inconsistent herewith are hereby confirmed, approved and ratified and continue to have full force and effect.

Section 11. Copies of this Ordinance be furnished to the Sangguniang Panlalawigan, the Land Bank of the Philippines, the Bangko Sentral ng Pilipinas (BSP), the Municipal Accountant and Municipal Auditor for their information and appropriate action.

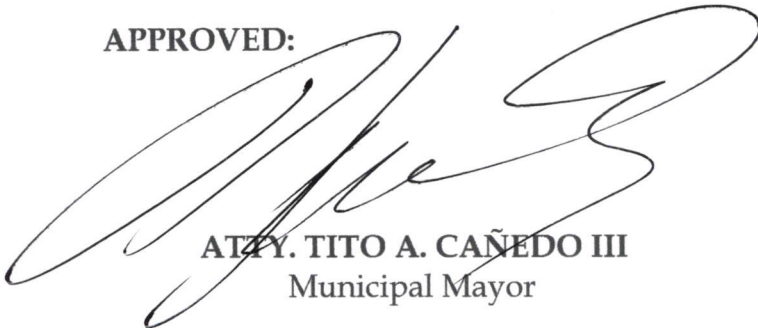
