



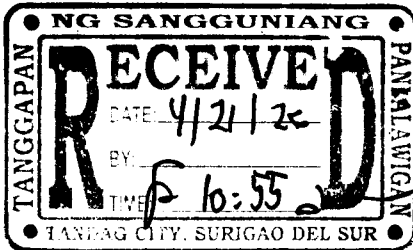

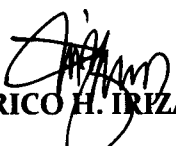

AN EXECUTIVE ORDER CREATING THE EXECUTIVE COMMITTEE (EXECOM) OF THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF THE LOCAL GOVERNMENT UNIT OF LANUZA, SURIGAO DEL SUR.

WHEREAS, Section 106-114 Republic Act 7160 of the Local Government Code establish Local Development Council at all levels.

WHEREAS, Municipal Development Council Executive Committee (MDC Execom) is a smaller body within the Local Government, Municipal Development Council (MDC) authorized to act on its behalf when the full council is not in session.

WHEREAS, ExeCom assist the Sanggunian Bayan Members in setting the direction and economic and social development and coordinating development efforts within this municipality and to coordinate development efforts within its territorial jurisdiction.

NOW THEREFORE, I ALGERICO H. IRIZARI, M.D., Municipal Mayor, by the virtue of the powers vested in me by the laws of the Republic of the Philippines, **DO HEREBY ORDER** the creation of the Executive Committee of this Local Government Unit.

Section 1: **TITLE:** This order shall be known as the EXECUTIVE COMMITTEE (EXECOM) OF THE MUNICIPAL DEVELOPMENT COUNCIL (MDC)

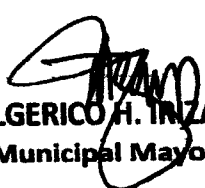
Section 3: **DUTIES AND FUNCTIONS OF EXECUTIVE COMMITTEE (EXECOM) OF THE MUNICIPAL DEVELOPMENT COUNCIL (MDC)**

1. To formulate policies and guidelines for MDC operation;
2. To review and recommend development projects;
3. To approve and endorse supplemental annual investment programs;
4. To coordinate with national agencies and stakeholders;
5. To perform other duties as assigned by the MDC;

Section 4: **THE REPEALING CLAUSE:** the committee is required to hold meetings regularly to review the progress of local development plans.

Section 5: **EFFECTIVITY:** This Executive Order shall take effect upon its signing.
