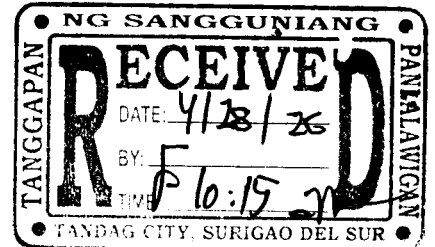

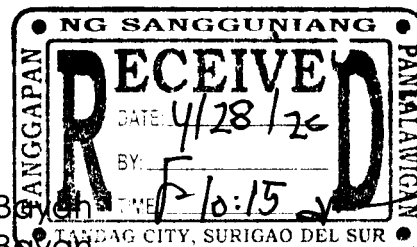

(MMP)" OF THE MUNICIPALITY OF MARIHATAG, SURIGAO DEL SUR,
PROVIDING MECHANISMS FOR ITS IMPLEMENTATION, APPROPRIATING
FUNDS THEREFOR, AND FOR OTHER PURPOSES

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the
Local Government Code of 1991, provides that every Local Government Unit
shall exercise powers necessary and appropriate for effective governance and
those essential to the promotion of the general welfare;

WHEREAS, Section 17 of the same Code mandates Local Government
Units to deliver basic services and facilities to their constituents in an efficient
and accessible manner;

WHEREAS, the Municipality of Marihatag is composed of twelve (12) barangays, seven (7) of which are coastal barangays and five (5) of which are upland barangays, whose residents require accessible, efficient, and responsive public services;

WHEREAS, certain geographical, economic, and transportation limitations may hinder some constituents from regularly accessing municipal services at the Municipal Hall;

WHEREAS, bringing municipal services directly to the barangays strengthens transparency, participatory governance, and responsiveness of the local government;

WHEREAS, the Municipal Government of Marihatag recognizes the spirit of "Matinabangon", which embodies cooperation, unity, and mutual assistance among Marihatagnons in achieving community development;

WHEREAS, there is a need to institutionalize a structured municipal outreach program that will deliver government services, promote community participation, and strengthen the relationship between the municipal government and the barangays;

NOW THEREFORE

BE IT ORDAINED, by the Sangguniang Bayan of Marihatag, Surigao del Sur, in session duly assembled:

SECTION 1. TITLE. This Ordinance shall be known as the **"Marihatagnon Matinabangon Program (MMP) Ordinance of 2026"** of the Municipality of Marihatag.

SECTION 2. PROGRAM IDENTITY AND THEME. The Program identity and theme shall be as follows:

A. The Program Identity. The Municipality of Marihatag hereby establishes and institutionalizes the Marihatagnon Matinabangon Program (MMP) as the official municipal outreach and service delivery program aimed at bringing government services, development initiatives, and community engagement activities directly to the barangays.

B. Program Theme. The program shall carry the theme: **"Serbisyon Matinabangon alang sa Marihatagnon"**.

SECTION 3. DEFINITION OF TERMS. For purposes of this Ordinance, the following shall be defined, to wit:

(1) Marihatagnon Matinabangon Program (MMP) – refers to the municipal program that brings government services, consultations, community activities, and development initiatives directly to the barangays of Marihatag.

(2) Matinabangon – refers to the spirit of cooperation, unity, and mutual assistance among Marihatagnons in working together toward community development, social welfare, and inclusive progress.

SECTION 4. DECLARATION OF POLICY. It is hereby declared the policy of the Municipality of Marihatag to:

- a) Ensure accessible delivery of municipal services to all barangays;
- b) Strengthen grassroots governance and community participation;
- c) Improve coordination between the Municipal Government and Barangay Officials;
- d) Provide a venue for direct consultation, grievance redress, and project monitoring; and
- e) Promote transparency, accountability, responsive leadership, and community unity.

SECTION 5. COVERAGE. This Ordinance shall apply to all twelve (12) barangays of the Municipality of Marihatag, Surigao del Sur.

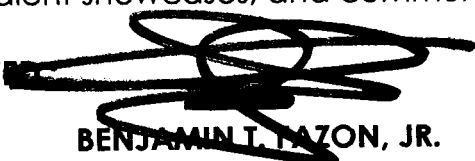
SECTION 6. OBJECTIVES OF THE PROGRAM. The Marihatagnon Matinabangon Program aims to:

- 1. Deliver essential municipal frontline services directly to constituents;
- 2. Conduct public consultations and town hall meetings;
- 3. Address complaints, concerns, and service requests;
- 4. Monitor implementation of ordinances and municipal and barangay-funded projects;
- 5. Provide technical assistance to barangay officials;
- 6. Facilitate medical, social welfare, agricultural, environmental, and business-related services;
- 7. Strengthen peace and order coordination; and
- 8. Promote unity, sportsmanship, and social cohesion through community activities.

SECTION 7. SERVICES AND ACTIVITIES TO BE DELIVERED. During the conduct of the Marihatagnon Matinabangon Program, the following services and activities shall be provided, but not limited to:

- a) Civil Registry assistance and document facilitation;
- b) Business permit and licensing assistance;
- c) Social welfare services and aid distribution;
- d) Medical dental and health services (consultations, check-ups, medicines subject to availability);
- e) Agricultural and fisheries technical support;
- f) Environmental protection, solid waste management, and disaster preparedness awareness;
- g) Legal consultation and grievance assistance;
- h) Tax information, assessment, and payment assistance;
- i) Youth, senior citizens, women, and PWD support services;
- j) Conduct of sports competitions and recreational activities to promote physical fitness, youth engagement, camaraderie, discipline, and community solidarity;
- k) Conduct of a Social Night or Community Fellowship Program, which may include cultural presentations, recognition of outstanding barangay members, talent showcases, and community-building activities; and

l) Other services and activities deemed necessary and appropriate by the Municipal Government to promote public service delivery and strengthen community relations.

SECTION 8. SCHEDULE AND FREQUENCY.

- a) Each of the twelve (12) barangays shall be visited **at least once every calendar year.**
- b) An Annual Barangay Visit Schedule covering all barangays shall be prepared by the Municipal Administrator and approved by the Municipal Mayor at the beginning of each fiscal year;
- c) Special visits may be conducted during emergencies, calamities, or urgent community concerns when necessary.

SECTION 9. COMPOSITION OF THE MUNICIPAL OUTREACH TEAM. The outreach team shall be composed of:

- Chairman : Municipal Mayor (Chairman of Delegation);
- Vice Chairman : Municipal Vice Mayor (Vice Chairman of Delegation)
- Members: Members of the Sangguniang Bayan;
- Municipal Administrator;
- All Department Heads
- Philippine National Police (PNP) Representative;
- Other concerned offices as necessary.

SECRETARIAT: Staff of the Office of the Mayor

SECTION 10. ROLES OF BARANGAY OFFICIALS. Barangay Officials shall:

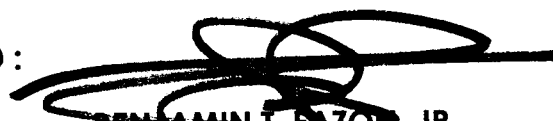
- 1. Assist in the preparation and coordination of the barangay visit;
- 2. Mobilize community participation by information dissemination through bandillo or any other form of public information.
- 3. Provide venue and logistical support;
- 4. Submit priority issues and development concerns of the barangay;
- 5. Assist in maintaining peace and order in the entire duration of the activity.

SECTION 11. DOCUMENTATION AND REPORTING. All activities conducted under the Marihatagnon Matinabangon Program shall be documented through reports, attendance records, and activity summaries. A consolidated **Annual Program Accomplishment Report** shall be submitted to the Municipal Mayor and the Sangguniang Bayan.

SECTION 12. FUNDING. The funding requirements for the implementation of the Marihatagnon Matinabangon Program, including expenses for logistics, service delivery, sports activities, and Social Night programs, shall be charged against the annual municipal budget under the Office of the Mayor or other appropriate offices, subject amounting to One Million Pesos (P1,000,000.00) to existing accounting and auditing rules and regulations.

SECTION 13. MONITORING AND EVALUATION. The Municipal Planning and Development Office shall develop monitoring indicators to evaluate:

- a. Number of beneficiaries served;
- b. Issues resolved;
- c. Projects monitored;
- d. Participation rate in sports and social activities;
- e. Community satisfaction level.

Provided that, an annual evaluation report shall be presented to the Mayor and Sangguniang Bayan.

SECTION 14. IMPLEMENTING RULES AND REGULATIONS. Within sixty (60) days from the effectivity of this Ordinance, the Office of the Mayor shall issue the necessary Implementing Rules and Regulations for its effective implementation.

SECTION 15. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, other provisions not affected thereby shall remain in full force and effect.

SECTION 16. REPEALING CLAUSE. All ordinances, resolutions, executive orders, or issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

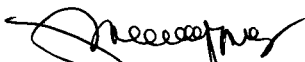
