

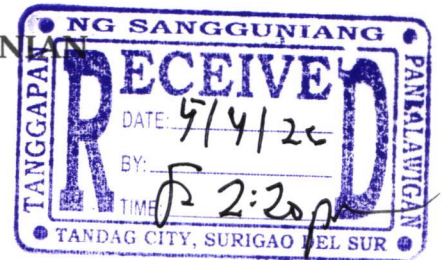

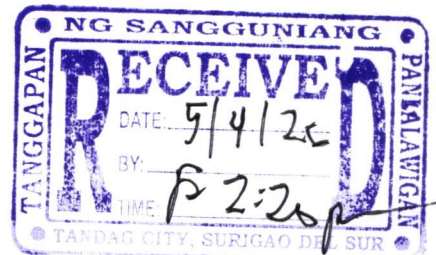

WHEREAS, the Municipality of Hinatuan is endowed with natural, cultural, historical, and special interest tourism attractions, including the renowned Enchanted River, which attract both local and foreign tourists;

WHEREAS, Section 79 of the Tourism Code of the Municipality of Hinatuan (Sangguniang Bayan Ordinance No. TC-013, Series of 2024) provides for the collection of a Tourism Fee from visitors to various tourism sites, including barangay-managed and privately-owned beaches, with proceeds supporting conservation, environmental protection, road maintenance, safety, and other tourism-related services;

WHEREAS, the establishment of a centralized and mandatory Tourist Drop-Off Point in the municipality is necessary to streamline tourist registration, facilitate efficient fee collection, provide orientation, ensure safety and security, and promote organized visitor flow;

WHEREAS, the Hinatuan Night Harbour, located in Barangay Aquino, Poblacion, Hinatuan, has been identified as the most strategic site for the mandatory drop-off point due to its central accessibility, proximity to municipal facilities, availability of parking and open space, and access to local tourism-related establishments;

WHEREAS, in view of the foregoing;

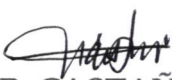
NOW THEREFORE;

RESOLVED, as it is hereby resolved, to approve, as this Body hereby approves the establishment of a Mandatory Tourist Drop-Off Point in the Poblacion for All Tourists visiting the Municipality of Hinatuan and designating Hinatuan Night Harbour in Barangay Aquino, in this Municipality.
