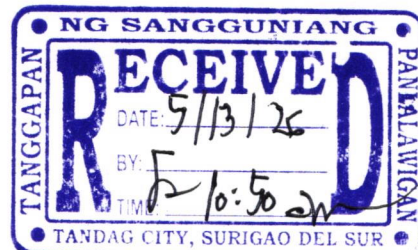

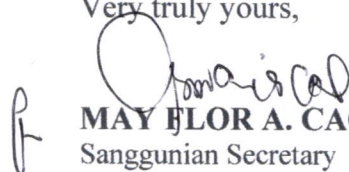

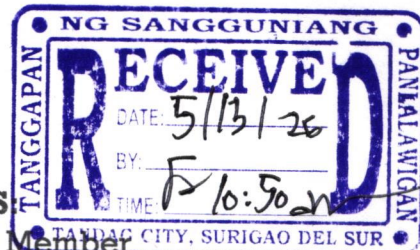

WHEREAS, one of the issues brought up to the plenary of the Sangguniang Bayan by the Committee Chair on Health during the September 2, 2025 regular session was the proposed increase of honoraria to Barangay Health Workers (BHWs) who are still actively servicing health cares to our constituents, particularly at the barangay Level;

WHEREAS, this Local Government Unit had enacted Municipal Ordinance No. 11, Series of 2017 Re: "Ordinance Granting Benefits and Incentives to Accredited BHWs in Form of Honoraria, this Municipality" dated November 7, 2017, wherein, Section 4 thereof provided an honorarium in each accredited BHW in the amount of Three Hundred Fifty Pesos (P350.00) per month whose funding allocation was included in the budget of the Municipal Health Office, regardless of the shared budget from the concerned barangay;

WHEREAS, with a span of eight (8) years, with its minimal amount of honorarium, the sum received by BHWs is no longer compensable with the most basic needs, thus, it is high time to increase their honorarium.

NOW THEREFORE:

BE IT ORDAINED, by the Sangguniang Bayan of Barobo, Surigao del Sur, in session, **THAT**:

Section 1. TITLE. This ordinance shall be known as the **"ORDINANCE INCREASING THE BENEFITS AND/OR INCENTIVES TO ACCREDITED AND ACTIVE BARANGAY HEALTH WORKERS (BHWs) IN FORM OF HONORARIA. THIS MUNICIPALITY, AS AMENDED, AND PROVIDING FUNDS THEREFOR."**

Section 2. POLICY. It is the policy of this Local Government Unit to recognize the BHWs indispensable healthcare services by uplifting their morale and further strengthen the primary health care delivery system.

Section 3. LEGAL BASIS. The legal basis on the grant of Incentives or Honoraria to BHWs is **Republic Act 7883** otherwise known as **"Act Granting Benefits and Incentives to Accredited Brgy. Health Workers and for Other Purposes."**

Section 4. COVERAGE. This Ordinance covers all accredited BHWs actively working in their assigned area of responsibilities/barangays under the supervision of the Municipal Health Office.

Section 5. ADMINISTRATIVE PROVISION. The Office of the Municipal Health shall undertake the inventory of all active and accredited BHWs who are recipients of this incentive/honorarium.

Section 6. ENTITLEMENT OF HONORARIA. Each active and accredited BHW is entitled to a monthly honorarium of Five Hundred Pesos (P500.00), **regardless of the sum shared by the concerned barangay.**

Section 7. APPROPRIATION. Appropriation for honoraria shall be sourced from the following:

a. Municipal Health Office	- 350.00
b. Sangguniang Bayan	
(Maintenance and Other Operating Expenses)	- 150.00
Total	- 500.00



Section 8. SEPARABILITY CLAUSE. If for any reason any section of provision of this ordinance shall be declared unconstitutional and invalid, the other sections or provisions which are not affected thereby shall continue to be in full force and effect.

Section 9. REPEALING CLAUSE. All previous ordinances which are inconsistent hereof are hereby repealed and modified accordingly.

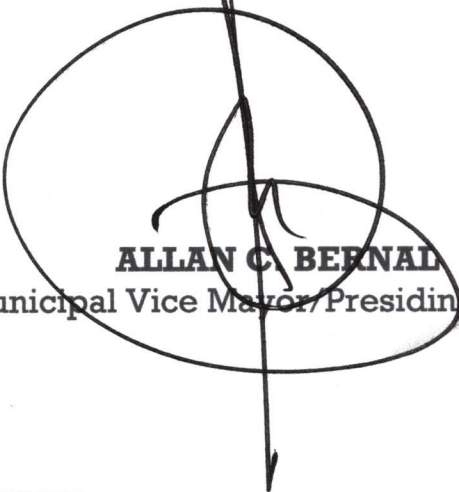
Section 10. EFFECTIVITY - This Ordinance shall take effect January 2026, and upon approval of the Local Chief Executive and Affirmation from the Sangguniang Panlalawigan.
