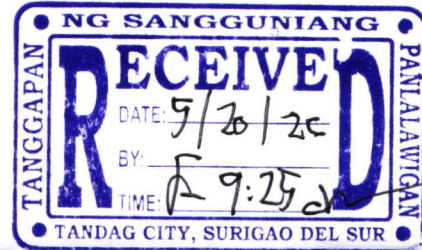

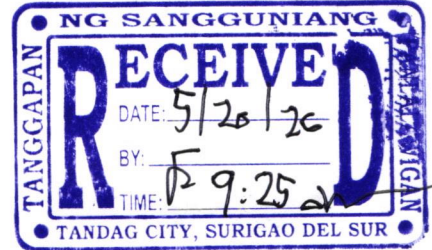

WHEREAS, the Sangguniang Panlalawigan of Surigao del Sur issued Sangguniang Panlalawigan Resolution No. 1053-26, recommending the temporary suspension of sports and other non-essential youth activities in view of the prevailing economic challenges and the need to prioritize urgent youth-responsive programs;

WHEREAS, this august body recognizes and respects the noble intention of the said resolution to ensure the prudent utilization of government resources and to address the pressing needs of the youth sector during economically challenging times;

WHEREAS, sports activities play a vital role in promoting physical fitness, discipline, camaraderie, teamwork, mental wellness, and youth development, while also serving as constructive avenues that help keep the youth away from illegal drugs, criminality, and other harmful influences;

WHEREAS, allowing privately funded sports activities to proceed will not entail additional financial burden on the government, considering that no public funds shall be expended for such purposes, including but not limited to prizes, uniforms, food, transportation, venue preparation, and other incidental expenses;

WHEREAS, the continuation of privately funded sports activities may contribute positively to community engagement, youth empowerment, and social development, while still upholding the intent of fiscal prudence embodied in the aforementioned provincial resolution;

NOW, THEREFORE, BE IT –

RESOLVED, AS IT IS HEREBY RESOLVED, to seek reconsideration of Sangguniang Panlalawigan Resolution No. 1053-26, entitled *“Recommending temporary suspension of Sports and Other Non-Essential Youth Activities in the Province of Surigao del Sur and encouraging reallocation of resources to urgent Youth-Responsive Programs amid the ongoing economic crisis,”* and respectfully request that sports activities funded solely by private individuals, organizations, sponsors, or initiatives be allowed to proceed, provided that no government funds are utilized for any related expenses thereof.

RESOLVED FINALLY, to furnish copies of this resolution to the Sangguniang Panlalawigan of Surigao del Sur, the Office of the Provincial Governor, concerned Local Government Units, and other concerned offices for their information/action on this matter.
