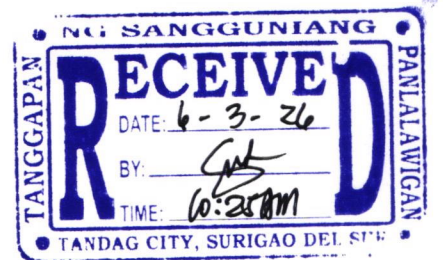

WHEREAS, President Ferdinand Marcos, Jr. declared the Philippines under a “State of National Energy Emergency” thru Executive Order No. 110 to mitigate the impacts of energy crisis in the Middle East;

WHEREAS, the Sangguniang Panlalawigan of Surigao del Sur promulgated Resolution No. 1082-26, Series of 2026 entitled “Declaring the Whole Province of Surigao del Sur under the State of Energy Emergency due to the Increase of Fuel Price and Other Oil Products;

WHEREAS, the Municipality of Carmen in response to the above issuances, suspends all activities and celebrations for the whole year and re-align funds to ensure food security and reliable transport systems especially during times of emergency, supply disruptions and other unforeseen events that may adversely affect the welfare of its constituents;

BE IT ORDAINED, by the Sangguniang Bayan of Carmen, Surigao del Sur, in Regular Session assembled, that:

Section 1. Use of Savings and Augmentation- In accordance with Section 336 of Republic Act No. 7160, the Local Government Code of 1991, the mayor is authorized to augment any item in the approved Annual Budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For this purpose, “savings” refer to portions or balances of any programmed appropriation free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation is authorized, or rising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay.

Augmentation implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources is determined to be deficient.

Section 2. Source of Funds- There is an available amount of One Hundred Sixty Thousand Pesos (Php160,000.00) from the Maintenance and Other Operating Expenses (MOOE) of the Municipal Social Welfare and Development Office, viz.

- 1) Children’s Month Celebration
 - Venue Preparation - Php 6,000.00
 - Sound System with LED Wall - Php 35,000.00
 - Meal and Snack for Guests and Staff (50pax x 300.00) - Php 15,000.00
 - Prizes - Php 22,100.00
 - Support to 11 CDC’s - Php 81,900.00

TOTAL: - Php160,000.00

Section 3. Expenditures- The amount of One Hundred Sixty Thousand Pesos (Php160,000.00) under Section 2 hereof will be utilized for funding requirements for the Reproduction of Learning Resource Package for CDCs.


Section 5. Effectivity – The provisions of this Ordinance shall take effect immediately upon approval.
