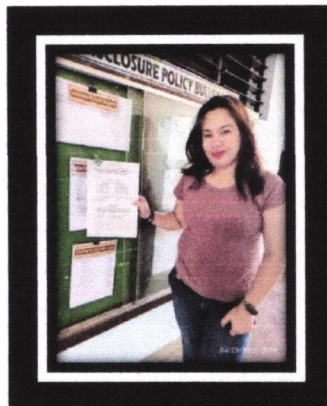
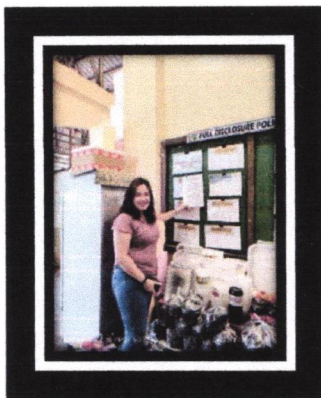

LEGISLATIVE DEPARTMENT”**

WHEREAS, the Legislative Department comprises three (3) Offices: The Office of the Vice Mayor, the Sangguniang Bayan, and the Office of the Sanggunian Secretary;

WHEREAS, among the legislative undertakings of the Sangguniang Bayan as mandated by law and as provided for in their Internal Rules Procedures (IRP) in aid to legislation, are the following:

WHEREAS, conduct of said activities outside of the official venue especially when it needs consultation with the concerned officials and constituents by "*Bringing the Government Closer to the People*" necessitates vehicle for a prompt and judicious delivery of services,

WHEREAS, absence of transportation has been a long burden of the Legislators and the Staff for an outright mobilization for the legislative activities mentioned in the preceding preamble;

WHEREAS, the Office of the Sangguniang Bayan has an approved Capital Outlay appropriation under the CY 2026 Annual Budget in the amount of One Million Eight Hundred Thousand Pesos (Php1,800,000.00) intended for the procurement of a service vehicle to support official functions, including but not limited to legislative activities, public hearings, committee meetings, and other official engagements conducted outside the Sangguniang Bayan Office;

WHEREAS, one of the programs under Appropriation Ordinance No. 4, S. 2025 (Third Supplemental Budget) was an allocation for the capital outlay amounting P250,000.00 programmed for the repair/improvement of the Rest Room;

WHEREAS, the Local Government Unit is anticipated to transfer to its new government center within the year, rendering the proposed improvement or repair of the existing comfort room no longer practical, cost-efficient, and necessary under present circumstances;

WHEREAS, Section 3 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, mandates local government units to ensure the effective and efficient delivery of basic services and the judicious use of public funds in accordance with sound fiscal administration.

NOW THEREFORE:

BE IT ORDAINED, by the Sangguniang Bayan of Barobo, Surigao del Sur, duly assembled in session, **THAT:**

SECTION 1. PURPOSE. The Purpose of Realigning the herein-described fund is for the purchase of Service Vehicle;

SECTION 2. AMOUNT OF SERVICE VEHICLE. The estimated amount for the purchase of Service Vehicle, including production of necessary papers, and other mandatory requirements for acquisition of government vehicle is P2,050,000.00.

SECTION 3. SOURCES OF FUNDS. The sources of funds for the purpose are the following:

- a. **Capital Outlay under the Office of the Sangguniang Bayan,
CY 2026**

-1,800,000.00

b. Fund Subject of Realignment reflected under CY 2025 Third Supplemental Budget programmed under the Office of the Sangguniang Bayan for Rehab/Improvement of Rest Room - 250,000.00

Total - 2,050,000.00

SECTION 4. COMPLIANCE WITH LAWS AND REGULATIONS. All disbursements and implementation of this Ordinance shall be subject to existing budgeting, accounting, auditing, and procurement laws, rules, and regulations, including guidelines issued by the Commission on Audit (COA) and the Department of Budget and Management (DBM).


SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in full force and effect.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon its approval and compliance with publication and posting requirements under existing laws.


